In the Name of God Amen I Anne Poore of Little Amesbury in the Parish of Great Amesbury in the County of Wilts Spinster being Sick and weak but of a good sound disposing mind memory and understanding Do make this my last Will and Testament in manner and form following Imprimis I Will that all such Debts As I shall justly Owe shall be well and truly paid Whereas my Grandfather Thomas Hayward late of Little Amesbury aforesaid Esq deceased in and by his last Will and Testament bearing date the tenth day of December One thousand seven hundred and ninety three among other things therein contained Did devise unto Thomas Beach of ffidleton in the County of Wilts Robert Duke Henry Biggs and Thomas ffrancis and the Survivors and Survivor of them All his Messuages Lands and Tenements in Little Amesbury and Great Amesbury upon several trusts therein mentioned Among which it was devised in trust and to the Intent and purpose that the said Robert Duke Henry Biggs and Thomas ffrancis and the Survivors and Survivor of them should by Leasing or Mortgaging the said Estate raise and pay to his Grandaughters Mary Poore and Ann Poore the Sum of three hundred pounds a piece of lawfull money of Great Britain within One year after his decease As by the said Will may Appear Which said Sum of three hundred pounds was not paid to me the said Anne Poor nor any Interest for the same from the time of the payment of the same directed by the said Will I the said Anne Poore do hereby give and bequeath unto my dear Sister Mary Poore the said Sum of three hundred pounds so devised by my said Grandfather Thomas Hayward And all Interest due or to be due for the same from the time of the payment of the same directed by the said Will Item the residue of All and Singular my Goods Chattels Bonds and ready money I give and bequeath to my said Sister Mary Poore And I do make my said Sister Mary Poore sole Executrix of this my last Will and Testament In Witness whereof I have hereunto set my hand and Seal the One and twentieth day of July 1726 Anne Poore her mark
