In the Name of God Amen I Mary Bundy Spinster of Amesbury being of sound disposing mind memory and understanding but mindful of mortality do on this thirteenth day of february in the Year of our Lord 1806 make and publish my last Will and Testament in manner and form following that is to say ffirst I desire to be Decently buried by my Sister Elizabeth Bundy in Church Yard at Amesbury I give and bequeath unto the Old and Sick Poor of the said Parish of Amesbury to be gave at two different times the Sum of Ten Pounds I also give to Miss Catherine Stiell the Sum of Ten Pounds I also give to my Cozen Grace Jesse of Bristol ffive Pounds likewise to her Brother William Privett ffive Pounds to Mrs Elizabeth ...all five pounds I give to John Carter of Willsford One Guinea to Spinster Ten Pounds if being my Servant at my death or going for her illness I give the Infirmary at Salisbury ffifty Pounds after Paying these my above funeral Expences and Legacys of this my Will I do give to my Sister Sarah Andrews of the Parish of All Saints Church Southampton after Paying all my ffuneral expences and Legacys and demands on any account have Slipt my memory I desire may be as soon as is Possible I give and bequeath to my Sister Sarah Andrews after her decease to her Husband Mr Simon Andrews Parish All Saints after his Death to his and her three Children Edward Sophia and Maria Andrews I do hereby make ordain and appoint my Sister Andrews my Sole Executrix of this my last Will and Testament hereby revoking all former Wills and Testaments by me made at any time In Witness I have to this my last Will and Testament In Witness I have to this my last Will and Testament set and Subscribed my hand and Seal the day and year above Written *Mary Bundy* In the presence of *Ann Mist Senr - Susanna Bundy*
