In the name of God Amen I Harry Telling of Ashton Keynes in the county of wilts Mason being of sound and disposing mind and memory praised be God for the same Do make and publish this my last Will and Testament in manner following First and principally I commend my soul to god and my Body to the Earth to be decently buried at the discretion of my Executor hereinafter named And so to my worldly Estate I dispose thereof as follows First I give to my son John Telling the sum of one Shilling Also I give to my Son Isaac Telling the sum of One Pound and one shilling to be paid to each of

them within one year after the decease of my wife Mary Telling also I give and bequeath unto my said Wife Mary Telling (after payment of all my just Debts Legacies and funeral Espences) All that my Cottage House Messuage or Tenement situate in Ashton Keynes aforesaid and all the Land which now is or hereafter shall be allotted to the same by the Commissioners named in and authorised by an Act of Parliament passed for the inclosing allotting and dividing the Commons and commonable places of Ashton Keynes aforesaid and all other appurterances to the said Cottage House Messuage or Tenement whatsoever belonging TO hold to my said Wife her Assigns for and during the Term of her natural Life and after the decease of my said Wife Mary I give and bequeath all the abovementioned premises unto my son Thomas Telling and his Wife Mary Telling for and during their natural Lives and the longer liver of them and from and after the several deceases of my said son Thomas Telling and Mary his Wife Then I give and Bequeath my said Cottage House Messuage or Tenement Garden and premises to the same belonging unto Ann the Daughter of my said Son Thomas Telling and her heirs for ever And I give and bequeath all the Land which is or shall be allotted to the same by the power and authority aforesaid unto John the son of my said son Thomas Telling and to his Heirs forever Also I give to my said Wife Mary Telling all and singular my personal Estate and Effects whatsoever and I make my said son Thomas Telling Sole Executor of this my Will IN WITNESS whereof I have to this my last Will and Testament set my Hand and Seal the first day of January in the Year of our Lord One Thousand Seven Hundred and Seventy Eight Harry Telling (his mark)
