Hurdcott

(Note: Hurdcott, a Hamlet about 1 mile south-east of Baverstock, in the county of Wilts. There is also a Hurdcott located near Winterbourne Earls, approximately 4 miles north-east of Salisbury, Wiltshire. With some newspaper notices it cannot be determined which Hurdcott is being referred to.)

BIRTHS

On Monday the lady of Alexander Powell, Esq. of Hurdcott House, in this county, of a son and heir.

On Sunday the 19th instant, at Hurdcott-House, the Lady of Alexander Powell, Esq, of a daughter.

(*Salisbury and Winchester Journal* – Monday 27 July, 1812)

On Saturday last, the Lady of Alexander Powell, Esq, of Hurdcott House, Wilts, of a son.

(*Salisbury and Winchester Journal* – Monday 16 August, 1824)

On Friday, June 8, at Hurdcott House, the lady of Richard Strachey, Esq., of Ashwick Grove, of a daughter.

(*Salisbury and Winchester Journal* – Monday 11 June, 1832)

Births – Sept. 12, at Hurdcott House, Wilts, the wife of the Rev. Reginald Pole, of a son.

(*Salisbury and Winchester Journal* – Monday 18 September, 1837)

Births – At Hurdcott, the wife of the Rev. Reginald Pole, a daughter.

(*Devizes and Wiltshire Gazette* – Thursday 15 November, 1838)

Births – Sept. 22, at Hurdcott, Wilts, the lady of the Rev. Charles Raikes Davy, a daughter, still born.

Births - May 14, at Hurdcott House, near Salisbury, the wife of the Rev. Reginald Pole, a daughter.

MARRIAGES

On Tuesday was married, at Willingham, in Cambridgeshire, Alexander Powell, Esq. of Hurdcott House, in this county, to Miss Joanna Law, second daughter of the Rev. Dr. Law, Prebendary of Carlisle, and niece of Lord Ellenborough.

Married, on Friday last, Mr Josiah Marshall, of Hurdcott, to Jane, second daughter of Mr Callaway, of the same place.

(Salisbury and Winchester Journal – Monday 10 October, 1831)

Married, on Saturday, Feb. 4, at Baverstock, by the Rev. W. E. Hony, Mr C. Bungey, of Burcombe, to Miss F. Green, of Hurdcott.

(Salisbury and Winchester Journal – Monday 6 February, 1832)

Married – On Thursday last, at Banwell, by the Lord Bishop of Bath and Wells, the Rev. Reginald Pole, rector of Sheviock, Cornwall, 3d son of the Rev. Dr Pole, rector of Barford St. Martin, Wilts, to Jane 3d daughter of Alex Powell, esq., of Hurdcott house, Wilts.

Married – On Thursday last, at Westbury, Wilts, by the Rev. T. A Methuen, M.A., Rector of Allcannings, Alexander Pitts Elliots, eldest son of Alexander Powell, esq., of Hurdcott, in this county, to Mary Elizabeth Vera Booth, only child if the late William Tyndale, esq., and grand-daughter if the late George Booth Tyndale, esq., of Bathford, Somerset.

Married – May 2 at Baverstock church, by the Rev. W. E. Hony, Mr Muselwhite, Officer of Excise, Tisbury, to Sarah, eldest daughter of Mr Nowlson, of Hurdcott Farm.

(Wiltshire Independent – Thursday 9 May, 1839)

Married – June 26, at Baverstock, by the Lord Bishop of Bath and Wells, the Rev. Thomas Garrett, third son of the late T. Garrett, esq., of Ellington, Kent, to Joanna, second daughter of Alex. Powell, esq., of Hurdcott, Wilts.

(Wiltshire Independent – Thursday 4 July, 1839)

Married – On the 7th inst., by the Rev. George Powell, the Rev. Charles Raikes Davy, only son of Lieutenant General Sir William G. Davy, C. B., and K. C. H., of Tracy Park, Gloucestershire, to Catherine Augusta, youngest daughter of Alexander Powell, esq. of Hurdcott, Wilts, and granddaughter of the Lord Bishop of Bath and Wells.

DEATHS

Yesterday in Salisbury, at an advanced age, after a short illness, Mrs Powell, relict of F. Powell, esq. and mother of Alexander Powell, esq. of Hurdcott-house, one of our county Magistrates.

Died on Wednesday inst. at her house in Castle-street, Salisbury, sincerely lamented, Anna Maria, relict of the late Francis Powell, Esq. of Hurdcott House, in this county.

Died - July 1, in his 13th year, Henry Lionell, youngest son of Alexander and Joanna Powell, of Hurdcott House.

(Devizes and Wiltshire Gazette – Thursday 6 July, 1837)

Died – December 25, Alexander Powell, of Hurdcott, Wilts, esq., aged 65.

Died, on the 22d inst., in the Close, Salisbury, Joanna, relict of Alexander Powell, Esq., of Hurdcott, Wilts.
