I William Lewis of Roundway in the Parish of Bishop's Canings in the County of Wilts Yeoman Do hereby Revoke all former wills and testaments by me made and do declare my Will to be as follows *Imprimis* I give to my Daughter Sarah wife of John Brind one shilling To my Daughter Mary wife of Thomas Sherwood one shilling To my son John Lewis ffifty pounds to be paid within one year after my decease To my Daughter Ann Lewis twenty pounds being in lieu of what was given to her by the last will of her Grandfather Robert Pope & by the last Will of her Uncle George Pope and lawfull interest to accrue therefore from my decease until the end of one year next after my decease provided nevertheless and thy Legacy is upon condition that she agree to accept the same in lieu & full satisfaction of what was so given to her by thesd. recited two wills as aforesd. And do give a proper Release therefore *Item* I give to her ffifty pounds more to be paid within two years after my decease. *Item* I give to my son George Lewis Twenty pounds being in lieu of what was given him by thesd. recited two wills & lawfull interest to accrue therefore from my decease for one year But it is my will that this legacy by him by the sd. recited two wills as aforesd. *Item* I give him the further sum of One hundred pounds to be paid within two years after my decease. *Item* I give him all my wearing apparell and in particular my long gun *Item* I give to my son Robert Lewis twenty pounds being in lieu of what was given him by thesd. recited two wills & lawfull interest to accrue therefore from my decease for one year upon condition he agree to accept the same in lieu & full satisfaction of what was so given to him by the sd. recited two wills as aforesd. & give a proper release therefore. *Item* I give him the further sum of ffifty pounds to be paid him within three years after my decease. *Item* I give to my Daughter Elizabeth Twenty pounds in lieu of what was given her by the sd. recited two wills and lawfull interest to accrue therefore from my decease a year upon condition she agree to accept the same in lieu & full satisfaction of what was so given to him by thesd. recited two wills as aforesd. & give a proper release therefore. *Item* I give to her the further sum of ffifty pounds to be paid within four years after my decease. *Item* after the sd. Legacys herein before by me given be first paid I give to my loving wife Sarah all my household goods & implemens of household. And all the rest of my estate whatsoever I give to my said wife and to my son William Lewis equally to be divided amongst them share & share alike And I do make my said wife and Son William Executrix and Executor of this my last Will & Testament Witnes my hand & Seal hereto set the twenty fourth day of January one thousand seven hundred twenty & nine and in the third year of the reign of King George the Second of Great Britain &c.

I William Lewis the testator within named do hereby make the following alterations in my within written Will (that is to say) I give unto my within named son George Lewis the sum of ffifty pounds of lawfull mony of Greta Britain over and besides the Legacys within mentioned to be given to him To be paid to him by my Executors within named within one year next after my decease And I do hereby further declare my Will to be that the Legacy my Will to be that the Legacy of one hundred pounds within mentioned to be payable to my said don George Lewis within two years after my decease shall be paid and payable to him within one year next after my decease any thing contained to the contrary notwithstanding And I do desire this to be taken as a codicill to and part of my within written Last Will and Testament which in all other respects not hereby by me altered I do hereby Ratify approve and confirm In Witness whereof I have hereunto set my hand & seal the Eighteen day of October Anno Din one thousand seven hundred thirty & one
