This is the last Will and Testament of me Thomas Timbrell of Bradford in the County of Wilts Dyer I give and bequeath unto my Son Thomas the sum of nine thousand pounds I also give and bequeath unto my Son Charles the sum of seven thousand pounds I also give and bequeath unto my Daughter Elizabeth the sum of eleven thousand pounds I also give

and bequeath unto my three Grandchildren Charles Spackman Thomas Spackman and James Spackman Children of my late Daughter Sarah the sum of ten thousand pounds equally to be divided between them share and share alike I give and devise unto my said daughter Elizabeth her Heirs and Assigns all that Tenement or Dwelling House and Premises called the Green Dragon and Carpenter's Shop thereto belonging situate in Bradford aforesaid late in the occupation of Thomas Spender and now of myself and John Smith and also all those Workshops thereto also adjoining in the occupation of Messrs Bush and Company and also all that Tenement or Dwelling House and Premises situate in the Bull Pit in Bradford aforesaid late in the occupation of Jonah Brown and also all that Close of Meadow or Pasture Ground in the old Almshouse Hill in the Parish of Bradford aforesaid in the occupation of Mr Adey to hold the same Hereditaments and Premises unto my said Daughter Elizabeth her Heirs and Assigns for ever I also give and bequeath unto my said Daughter Elizabeth all and every my Household Goods ffurniture Plate Linen and China I give and devise unto my Grandson the said Charles Spackman his Heirs and Assigns all that Tenement or Dwelling House Workshop Stable Gardens and Premises situate lying and being at the top of a lane called Coppin Lane in the Parish of Bradford aforesaid now Rented of me by Mr Edward Cooper and which premise I purchased of the Executors of the late Duke of Rutland to hold unto him my said Grandson Charles Spackman his Heirs and Assigns for ever All the Rest and Residue of my ffreehold and Leasehold Messuages Lands Tenements Hereditaments and Premises whatsoever and wheresoever I give devise and bequeath unto my said Son Thomas to hold unto my said Son Thomas his Heirs Executors Administrators and Assigns according to my several and respective Estates and Interest therein All the Rest residue and remainder of my Goods and Chattels Rights Credits and Personal Estate and Effects whatsoever and wheresoever and of what nature or kind soever except my Gold Watch which I give unto my said Grandson Charles Spackman my ffuneral expences debts and legacies being thereout first paid and discharged and a Monument erected to my memory I give and bequeath unto my said Sons Thomas and Charles and unto my said Daughter Elizabeth equally to be divided between them share and share alike and I appoint them my said Sons Thomas and Charles and my said Daughter Elizabeth Executors and Executrix of this my last Will and Testament hereby revoking all former Wills by me at any time heretofore made In Witness whereof I the said Thomas Timbrell the Testator have to this my last Will and Testament contained in two sheets of paper to the first sheet set my Hand and to this second and last Sheet my Hand and Seal this eighteenth day of April in the year of our Lord one thousand eight hundred and fourteen *Thos Timbrell*
