Henry Whitaker of Bratton, yeoman, revokes all former wills, friends William Axford of Erlestoke, county Wilts, gentleman, John Drewett of Bratton, James Salmon of Burnett, county Somerset, Jeffrey Whitaker of Bratton, schoolmaster, their executors and administrators, all his estate at Chapmanslade held under Viscount Weymouth, his estate at Bratton held under William Phipps esq., and his estate at Bratton called Frickers in trust for son John Whitaker during his life, and in

trust for any child or children on whom he shall settle the same, and in default of such settlement to the use of the said children of the said John equally divided; in default of his issue, to the use of the testators wife Elizabeth; after her death to his nephew Thomas son of his brother Phillip Whitaker; but the estate at Bratton held under William Phipps and Frickers to his nephew Alridge Whitaker son of Alridge Whitaker deceased; said son his best silver tankard, best "scrutoir" half a dozen silver spoons and silver watch, rest of the goods to his executrix, to Elizabeth his wife.
