1802

Lot 11. A close meadow or pasture containing by estimation five acres (be the same more or less) situate in the parish of Bremhill, in the county of Wilts, within easy distances of the market towns of Chippenham and Calne, and now in the occupation of Andrew Dansey, as tenant thereof. The tenant will show the premises; and for further particulars apply to Mr Guy, attorney, Chippenham.

1807

To let or lease for seven years from Lady Day 1807. 1st a dwelling house, with suitable buildings, and about 31 acres of arable and 50 of pasture land, tythe free, in the occupation of Jacob Hammond, in the parish of Bremhill, about three miles from the town of Calne. Also a dwelling house and about 25 acres of pasture and 5 of arable land, in the occupation of W and J Hodges, in the parish of Bremhill, also tythe free. Also a dwelling house with suitable buildings, and about 49 acres of pasture and 55 of arable land, in the occupation of William Gingell, at Studley in the parish of Calne, free of great tythe.

1810

All that farm situate at Hanger in the parish of Bremhill, in the county of Wilts, in the occupation of Mr Thomas Hale; containing 81½ acres of arable, meadow and pasture land, or thereabouts, with a dwelling house and necessary outbuildings, free from tithes. Further particulars may be had on application to Mr Broad, Bowood, near Calne; to whom sealed proposals may be sent till the 28th of February 1815. 1824

To be sold at auction by Mr Forrest On Wednesday 21 July at 12 o'clock, at Garraway's Coffee House, Change Alley, Cornhill, London. A freehold Estate situate in the parish of Bremhill, in the county of Wilts, about 4 miles from the market towns of Calne and Chippenham, and 11 from Devizes; consisting of a very improvable dairy farm called Bremhill Grove, containing 132 acres of land, chiefly meadow and pasture, tithe free, lying very compact, in convenient inclosures, with a farm house and outbuildings; now in the occupation of Mr Edward Rawlings, a yearly tenant. This estate is intersected by the Wilts and Berks Canal, affording a ready and cheap conveyance for the produce and manure to and from the capital markets of Calne, Devizes, Bath and Bristol.
