In give unto Eliz: Daughter of John Wisdome twenty pounds of like lawfull English money to be paid as abovesaid upon one whole yeare after my decease and thenly to be put forth to the best advantage of the said Elizabeth untill she come to the age of 21 yeares It. I give unto Ann Daughter of the said John Wisdome one two yeare olde heifer All the rest of my goods and chattells not given I give and bequeath unto Elizabeth my Wife and do make her the whole and sole Executrix my debts and funerall expences discharged of all things moveable and unmovable to dispose of the said goods to the use of her Daughters And do nominate and appoint Thomas Shepperd and Nicholas White to be my Overseers of this my last will and testamt And doe give them for theyr paines xiid a peece In ©Wiltshire OPC Project/Year/Transcriber
