This is the last Will and Testament of me William Fry of Bremhill in the County of Wilts Yeoman made and published this twenty third day of April in the Year of our Lord one thousand eight hundred and one in manner and form following that is to say first I will and direct that all my just debts and funeral Expences be fully paid and discharged Then I Give devise and bequeath unto my beloved Mother Mary ffry all and singular my Estate and Effects whatsoever and wheresoever both

real and personal for the Term of her natural Life And from and immediately after her decease I Give devise and bequeath unto my Nephew John ffry Son of my Brother John ffry now residing in the Conigre ffarm in the Parish of Calne in the said County of Wilts Yeoman All that my Messuage or Tenement Garden Orchard Buildings and Premises thereunto belonging situate in Calne Quarry in the Parish of Calne aforesaid which I lately purchased of and from Robert Oakford To hold unto my said Nephew John ffry Son of my said Brother John ffry and to his Heirs and Assigns for by and during all the Rest Residue and Remainder of the several Terms therein yet to come and unexpired But it is my Will Interest and meaning And I do hereby order and direct that my said Brother John ffry shall from and immediately after the decease of my said Mother enter into and upon the said Premises and every Part thereof and shall receive the rents Issues and Profits thereof and every part thereof until my said Nephew John ffry his Son shall attain his full age of twenty four Years But if it shall happen that my said Nephew the said John ffry shall die before he attains his said age of twenty four Years then I give devise and bequeath the said Messuage or Tenement and Premises hereinbefore mentioned with the appurts unto my said Brother John ffry and to his Heirs for and during all the Residue and Remainder of the said several Terms therein then to come and unexpired Also I Give unto my Sister Jane Wheeler the Sum of Ten Pounds Also to my Brother Joseph ffry the Sum of ffive Pounds Also to my Sister Ann Holly the Sum of Ten Pounds Also to my Nephew Joseph Wheeler Son of my Sister Jane Wheeler the Sum of ffifteen Pounds All which said Legacies I will and direct shall be paid when and as soon as my said Mother shall have been dead one Year All the Rest Residue and Remainder of my Estate and Effects whatsoever and wheresoever both real and Personal I give devise and bequeath unto my said Brother John ffry (after the death of my said Mother)and to his Heirs and Assigns for ever And I do make nominate and Appoint my said Mother and Brother John ffry Executrix and Executor of this my said Will In Witness whereof I have hereunto set my hand and Seal the day and Year first above written The mark of William Fry X
