In the Name of God Amen I Jacob Henly of Grittenham in the Parish of Brinkworth in the County of Wilts yeoman being in a Weak State of Health but of sound and disposing mind and memory thanks be given to God for the same Do make my last will and testament in manner following that is to say ffirst I give to Mary Armon the sum of three hundred pounds of good and lawful money I also give and bequeath to my Sister Mary Henly the sum of three hundred pounds also I give and bequeath unto my Niece Joanna Armon the Sum of four hundred pounds also I give and bequeath unto my Niece Ann Armon the Sum of three hundred pounds also I give and bequeath unto my Niece Elizabeth Bromhill the Sum of three hundred pounds and my Will is that the said two several Legacys of three hundred pounds each given to my said two Sisters shall upon the Decease of them or either of them be equally divided between my said three Nieces share and share alike also I give and bequeath unto my Uncle William Henly the Sum of ffifty Pounds but if he should Die before he may be entitled to receive the same I give and bequeath such Legacy to be equally divided between the children of the said William Henly Also I give and bequeath unto my Aunt Ann Robbins the Sum of ffifty Pounds but if she should Die before she may be entitled to receive the same I give and bequeath such Legacy to and among the Daughters of the said Ann Robbins share and share alike also I give and bequeath unto my Kinsman Jasper Rumball Son of Bryant Rumball the Sum of ffifty Pounds Also I give and bequeath unto my two Kinswomen Ann Jacobs and Jane Isles fforty pounds Apiece to be Paid them at such times and by such Proportions as my Executors hereinafter named or the survivors of them shall think fit and convenient also I give and bequeath unto my Kinsman Robert Stone the Sum of fforty Pounds Also I give and bequeath unto my Kinsman Robert Henly of Spintal the Sum of fforty Pounds Also I give and bequeath unto my Kinsman Thomas Henly of Preston the Sum of ffifty Pounds Also I give and bequeath unto the Church Wardens and overseers of the Poor of the Parish of Brinkworth the Sum of ten pounds to be by them distributed to the Second poor of the Parish of Brinkworth aforesaid Also I give to the Poor of Bronthoraus Church of Tetheaton in the said County of Wilts Ten Pounds to be distributed among them by my said Executors or the Survivor of them Also I give to my Brother in law Thomas Armon my Watch and Silver Shoe Buckles Also I give all my Wearing Apparel of every Sort and kind to my said Kinsman and Kinswoman Robert Stone and Jane Isles and to my Servant Man to be equally divided between them share and share Alike also I give all my Household Goods ffurniture and Utensils of Household among my said three Nieces equally Except Dairy Vessels and Utensils of every Sort and kind which my Will is shall be taken as Part of the Stock upon my Dairy ffarm Item all my ready Money and Securities for Money Stock of all kinds Debts Chattels and Personal Estate not hereby Otherwise disposed of my Debts Legacys and ffuneral Expences being thereout first paid and Deducted I give and bequeath the same to my Uncle Jacob Henly and my Kinsman Abraham Henly Son of my late Uncle Thomas Henly equally share and share alike and I do make and appoint the said Jacob Henly and Abraham Henly Joint Executors of this my last Will and Testament In Witness whereof I have hereunto set my hand and Seal the Seventh day of August one thousand Seven hundred and eighty *Jacob Henly*
