Education of my son Samuel and my daughter Mary untill they shall attain to the age of one and twenty years and immediately after my said son Samuel and my daughter Mary shall attain to their respective Age or Ages of one and twenty years I do hereby order my said Executor to make an equall Dividend of my said Estate as shall be then left between them share and share alike And further my Will and meaning is and so by me declared to be the true and intent and meaning hereof that in Case my said son Samuel or my daughter Mary should happen to decease before he or her shall attain to the age of one and twenty years then I do hereby order all the Moiety or half part of my said Personal Estate belonging to the Person so deceasing to the Survivor of them And I do hereby ordain constitute and appoint my said Brother Thomas Neate to be the full and whole Executor of this my last Will and Testament And Lastly I do desire my loving ffreinds John Jouds of the Derry Hill in the said County of Wilts Drugget maker and John Barrett of the Devizes in the said County Baker trustees of this my last Will and Testament to see the same duly executed and performed And I do hereby revoke frustrate and make void all Will or Wills by me formerly made And do declare this to be my last Will and Testament In Witness whereof I have to this my last Will and Testament sett my Hand and Seal this twenty ninth day of April in the tenth year of the Reigne of our Sovereigne Lord George the second by the Grace of God of Great Britian ffrance and Ireland King Defender of the ffaith and so forth and in the year of Our Lord one thousand seven hundred and thirty seven *John Neate*.
