This is the last Will and Testament of me of me Sarah Bleaden of Calne in the County of Wilts Widow made this tenth day of January in the year of our Lord one Thousand Eight Hundred and Six as follows (that is to say) first I Give and bequeath unto Benjamin Bowman of Calne aforesaid Buthcher and to my Nephew in Law Charles Bleaden of Calne aforesaid Yeoman the Sum of Two Hundred Pounds of lawful Money Current in Great Britain to be paid to them to be paid to them the said Benjamin Bowman and Charles Bleaden by my Executrix hereinafter named by my Executrix hereinafter

named within one Month next after my decease Upon Trust that they the said Benjamin Bowman and Charles Bleaden or the Survivor of them or the Executors or Admors of such Survivor do and shall with all Convenient Speed put place out and invest the said Sum of Two Hundred Pounds on Government or such other good and sufficient Security or Securities as they in their discretion shall think fit and pay and supply the Interest and Dividends thereof from time to time and as often as they shall receive the same unto and to the sole use and benefit of my Brother Thomas Nash of Swindon in the said County Yeoman and his Assigns during the Term of his natural life and from and immediately after his decease Upon Trust that they the said Benjamin Bowman and Charles Bleaden and the Survivor of them or the Executors or Admors of such Survivor do and shall as soon as possible next after my Brother's decease call in the said Sum of Two Hundred Pounds and pay and apply and divide the same and every part thereof together with all Interest Dividends and Proceeds thereof as shall be then due thereon unto and among all and every the ligitimate Child and Children of my said Brother who shall be living at the time of his decease in equal parts shares and proportions to and for his her and their proper use and benefit and for no other use Trust Intent or purpose whatsoever Also I Give and bequeath unto my Sister Betty Herring (Widow of Thomas Herring late of Swindon aforesaid Victualler) the Sum of one Hundred pounds of lawful Money of Great Britain Also I Give and bequeath unto my Sister Mary the Wife of William ffarmer of Swindon aforesaid Gentleman the Sum of One Hundred Pounds of like lawful Money for sole and seperate use and disposal exclusive of her said Husband and not to be subject to his Debts management or controul but the Receipt of the said Mary ffarmer alone notwithstanding her coverture to be a sufficient discharge for the same Also I Give and bequeath to my Nephew in Law the said Charles Bleaden the Sum of One Hundred Pounds of like lawful Money Also I Give and bequeath unto my Niece Hannah Bailey of Calne aforesaid Spinster (Daughter of William Baily late of Swindon aforesaid Victualler deceased) the Sum of ffifty Pounds of like lawful Money all which said several Legacies I do hereby direct and appoint shall be severally paid and discharged by my Executrix hereinafter named within twelve Months next after my decease and all the Rest Residue and Remainder of my Estates both Real and Personal of whatsoever nature kind or quality the same may be and consist of and wheresoever situate I Give Devise and bequeath the same and every part and parcel thereof with their and every of their appurts unto my Niece Diana Sarah Nash of Mortlake in the County of Surrey Spinster To hold the same and every part and parcel thereof unto my said Niece Diana Sarah Nash her Heirs Executors Admors and Assigns for ever and I do hereby nominate constitute and appoint my said Niece Dianah Sarah Nash whole and sole Executrix of this my Will and revoking all former and other Wills by me at any time heretofore made do declare this to be my last Will and Testament In Witness whereof I have to this my last Will and Testament contained in two Sheets of Paper set my hand to the first sheet thereof and my hand and seal the last sheet thereof the day and year first above written Sarah Bleaden
