Chíppenham 1800-1849

1828

Committed to the House of Correction, Devizes Thomas Field, of Chippenham, James Norris of Hilperton, James Strange, of Corsham, John Garrett, of Warminster, and Benjamin Woods, of Codford St. Mary, for three months each, for breaches of the Game Laws. Salisbury and Winchester Journal, Monday, 21 January 1828

1833

Committed to the House of Correction, Devizes Robert Clarke, for one month, for assaulting Benjamin Jacques, of Chippenham Bath Chronicle and Weekly Gazette, 21 November 1833

Committed to the Old Bridewell, Devizes the property of Harry Russ, of Chippenham

Jacob Smith, charged with stealing 4 bushels of barley, Bath Chronicle and Weekly Gazette, 21 November 1833

1835

Committed to House of Correction, Devizes. Thomas Gough, for two months, for assaulting John Heritage, of Chippenham. Devizes and Wiltshire Gazette, 3 September 1835

Committed to House of Correction, Devizes. Jane Driskell, for one month, for having committed an act of vagrancy, at Chippenham. Devizes and Wiltshire Gazette, 3 September 1835

1838

Committed to The New Prison, Devizes Thomas Gough, and John Bridgeman, for two months each, for willfully damaging a chestnut tree, the property of Robert Humphries, esq., at Chippenham. Wiltshire Independent, Thursday, 22 February 1838

Committed to The New Prison, Devizes Isaac Harper, for two months, for assaulting William Watts, at Chippenham. Wiltshire Independent, Thursday 22 February 1838

1839

Committed for Trial. John White, charged with having stolen apparel, the property of Thomas Wiltshire, also further charged with having stolen apparel, the property of Thomas Newman, at Chippenham. Wiltshire Independent, 28 November 1839

1841

Committed to the New Prison Devizes Ruth Cherry, for three weeks, for disorderly conduct in the workhouse at Chippenham. **Devizes and Wiltshire Gazette, 11 February 1841** ©Wiltshire OPC Project/2013/Jodi Fuller Revised 12 February 2024 by Teresa Lewis Salisbury Assizes William Anslow, for stealing a shovel, the property of George Wiltshire, at one months' hard labour. Salisbury and Winchester Journal, Monday, 8 March 1841

1843

John Callis, charged with having stolen one mahogany plank, the property of John Provis, at Chippenham. Guilty: 7 years transportation. **Wiltshire Independent**, **12 January 1843**

1847

Committed to The New Prison, Devizes. Charles Todd for three weeks, for disorderly conduct in the workhouse at Chippenham. Devizes and Wiltshire Gazette, 20 May 1847

Committed to The New Prison, Devizes. For Trial Caruling Slade and Eliza Slade, charged with stealing three pieces of cheese, six loaves of bread, and about half a pound weight of butter, from the dwellinghouse of Catherine Lawes at Chippenham. **Devizes and Wiltshire Gazette, 20 May 1847**

Francis Mountin, for stealing a mare, the property of Wm. Caudle, at Chippenham, also Francis Mountin, stealing a mare, the property of Edward Howell. Sentenced to 7 years transportation **Devizes and Wiltshire Gazette, Thursday, 28 October 1847**

John Lawrence, stealing a pair of boots, the property of Daniel Cook, at Chippenham. Sentenced to 2 months imprisonment. **Devizes and Wiltshire Gazette, Thursday, 28 October 1847**
