In the Name of God Amen I William Farr of Chippenham in the County of Wilts Clothier being weak in Body but of sound and perfect Mind and Memory and calling to Mind the great uncertainty of Life Do hereby dispose of my Worldly Estate and make publish and declare this my last will and Testament in manner following That is to say ffirst I will that all my just Debts and ffuneral Expences be paid and satisfied I give and bequeath to my Nephew William ffarr the sum of one shilling Also I give and devise to my loving Wife Jane ffarr All and singular my Lands Tenements Hereditaments and Premises with its Appurtenances situate lying and being in Chippenham aforesaid and in the Parish of Chippenham aforesaid And

all other my Real Estate or Estates whatsoever or wheresoever To hold the same to my said Wife Jane ffarr her Heirs and Assigns for Ever Also I give and bequeath to my said Wife Jane ffarr and her Heirs All and singular my Goods Chattells and Personal Estate or Estates whatsoever (be it of what nature or kind soever) to take the same to her and their own proper use and benefit immediately after my Decease And I do hereby constitute and appoint my said Wife Jane ffarr whole and sole Executrix of this my last Will and Testament And I do hereby appoint my ffriends Thomas Godwin of Langley in the Parish of Kington St Michael in the County aforesaid Yeoman and Samuel Rumsey of the Parish of Rowd in the said County of Wilts Yeoman Overseers In Trust of this my last Will and Testament desiring that they will see the same duly performed and for their Care herein I give and bequeath to each of them the sum of one Guinea of lawful Money of Great Britain to be paid unto them in one Year next after my Decease And I do hereby revoke disannull and make void all will or wills by me at any time heretofore made and declare this to be my last Will and Testament In Witness whereof I have to this my last Will and Testament set my Hand and Seal this second day of May in the Year of our Lord Christ One Thousand seven Hundred and fforty three *William Farr*
