This is the last Will and Testament of me John Parham late of Pertwood but now of Chittern St Mary both in the County of Wilts which hereby revoking all other Wills I make and publish as follows I give and bequeath all that my Leasehold Estate Lands and Heredits situate at Donhead St Andrew Wilts unto and to the use of my dear Wife Mary and her assigns for her life and from and after her decease I give and bequeath the same Estate and Premises unto and to the use of my son John Parham To hold to him his heirs Executors admors and assigns for the lives terms Estate and Interest I may have therein according to the nature and tenure thereof and as to all other my Lands Tenements and Heredits as well Real Leasehold and Copyhold and whatsoever and wheresoever situate I give devise and bequeath the same unto and to the use of my said Wife and her assigns for her life and from and immediately after her decease I give devise and bequeath the same Heredits and Premises with the Appurts unto and to the use of my son George Parham and to his Executors admors and assigns according to the nature and tenure thereof respectively for Ever or for the lives terms Estate and Interest I may have therein respectively I give and bequeath unto my said dear Wife all my Household Goods furniture Plate Linen China Liquors and fuel and also the Sum of one hundred pounds of lawful money of Great Britain to and for her own use and benefit and I give and bequeath unto each of my three Daughters Charlotte Harriet and Mary the Sum of

fifty pounds a piece free of all Legacy Duty and as to all other my Monies and Securities for money Goods Chattels Estate and Effects whatsoever and wheresoever subject to the payment of my Debts ffuneral Expences and Legacies and also subject to the payment of one clear annuity or yearly Sum of one hundred pounds of lawful money of Great Britain to my said dear Wife and her assigns for and during her natural life and which I give and bequeath to her and direct my Executor to secure the same to be paid to her by quarterly even payments from the day of my decease by his Bond I give and bequeath the same to my said son George Parham to and for his own use and benefit and I nominate constitute and appoint my said son George Parham sole Executor of this my Will In Witness whereof I have hereunto set my hand and seal this twenty fifth day of January in the Year of our Lord 1821 *John Parham*
