In the Name of God Amen I Isaac Woodward of the Parish of Clyffe Pypard in the County of Wilts Yeoman being in good health of body and of sound mind memory and understanding do make ordain constitute and appoint this my last will and Testament in the following manner and form (that is to say) I first and principally resign my Soul to God my Creator hoping for mercy thro the merits of Christ my Redeemer and my body I commit to the Earth to be buried in a Christian manner and since it hath pleased God to bless me in this life I give devise and dispose in the following manner Imprimis to my Son

William I bequeath the sum of Thirty Pounds of good and lawful money of Great Britain Item to my Son Paul I bequeath the sum of fforty Pounds of good and lawful money of Great Britain Item to my Daughter Mary Alderman Wife of James Alderman of the Parish of Lyneham in the said County of Wilts I bequeath the sum of forty Pounds of like lawful money of Great Britain Item to my Daughter Elizabeth Crew I bequeath the sum of Eighty Pounds of the like lawful money of Great Britain to be paid by my Executor after mentioned in the following manner (that is to say) ffive pounds yearly and every year till the said Eighty pounds are expended at the said ffive pounds a year the ffirst payment to begin one year after my Decease and so to continue every year till the said Eighty pounds is expended and if my said Daughter Elizabeth Crew should happen to die before the term of the said Eighty Pounds be paid in the manner aforesaid my Will is to have it paid equally among her Children that is for the residue and remainder of the said Eighty pounds that should be then unpaid to be paid as aforesaid ffive pounds yearly equally divided amongst her Children till the residue and remainder of the said Eighty pounds is expended And my Will further says that her Husband John Crew shall have no right claim nor title to any of the said Eighty Pounds or any of my effects Item to my Daughter Elizabeth Crew I bequeath All that Messuage or Tenement Garden and all thereunto belonging situated at ffoxham in the Parish of Brinhills in the County of Wilts and after my Daughters decease my Will is to give it to my Grand Daughter Hannah Crew Daughter of the said Elizabeth Crew the residue Item I appoint my Son Isaac Woodward my whole and sole Executor of this my last will and Testament and he shall not pay no Legacies until one full year and a half after my Decease and do hereby utterly revoke disallow and disannul all former bequests Will and Legacies by me heretofore left or made declaring ratifying and confirming this and no other to be my last will and Testament In Witness whereof I have hereunto set my hand and seal this fifteenth day of April in the Year of our Lord One thousand seven hundred and ninety six *Isaac Woodward*
