## Will of Joseph Pinchin

## Proved 1836



In the Name of God Amen I Joseph Pinchin the elder of the Parish of Colerne in the County of Wilts ffarmer being weak in body but of sound disposing mind memory and understanding for which I desire to be truly thankful to Almighty God the Author thereof do make this my last Will and Testament in manner following (that is to say) ffirst I will and direct that all my just debts funeral and testamentary expences and the costs and charges of proving this my Will be fully paid and satisfied by my Executor hereinafter named I give devise and bequeath unto my dear Wife Elizabeth Pinchin All my business stock in trade and all my household furniture plate linen china and implements of household whatsoever for her own use and benefit during the term of natural life I give unto my son David Rice Pinchin All those my freehold premises with the Appurtenances thereunto belonging and in which he now situate lying and being in the Parish of Box in the said County of Wilts but subject to the payment of one hundred pounds of lawful money of Great Britain thereof unto my Executor hereinafter named To hold the same and every part thereof unto my said son David Rice Pinchin his heirs and assigns for ever I give unto my son Joseph Pinchin All that my freehold messuage tenement and dwelling house with the appurtenances situate lying and being in the said Parish of Colerne now in the tenure or occupation of John Weeks And also all that freehold messuage or tenement situate in the said parish of Colerne and now in the tenure or occupation of Mr David Green And also all that freehold messuage or dwelling house with the Bakehouse and Malthouse and five acres of Arable land with the appurtenances situate lying and being in the Parish of Old Sodbury in the County of Gloucester To hold all and singular the above mentioned premises with their appurtenances unto and to the only proper use of my said son Joseph Pinchin his heirs and assigns for ever I give unto my son Henry Pinchin All that my freehold messuage tenement or dwelling house with the garden and appurtenances thereunto belonging situate lying and being in the said Parish of Colerne and now in the tenure or occupation of John Clark To hold all and singular the said premises with my appurtenances unto my said son Henry Pinchin his heirs and assigns for ever I give to my daughter Elizabeth Brokenbro Wife of John Brokenbro of Rudloe in the Parish of Box the sum of one hundred pounds of lawful money of the United Kingdom of Great Britain and Ireland Current in England which I direct shall be paid to her at the end of three years after my decease I give to my daughter Ann Pinchin the sum of three hundred pounds of lawful money of the United Kingdom of Great Britain and Ireland Current in England which I direct shall be paid to her by my Executor hereinafter named by instalments out of my stock in trade after the expiration of three years from the time of my decease And after the decease of my Wife Elizabeth Pinchin I give the whole of my business stock in trade furniture plate linen china and implements of household hereinbefore by me given and bequeathed to my said Wife for her life unto my said son Joseph Pinchin his executors administrators and assigns All the rest residue and remainder of my real and Personal Estate and Effects whatsoever and wheresoever not by me hereinbefore given and bequeathed (if any) I give and bequeath the same unto my son the said Joseph Pinchin And I do hereby nominate and appoint my said son Joseph Pinchin sole Executor of this my Will and hereby revoking and making void all former and other Wills by me at any time heretofore made do declare this only to be my last Will and Testament In Witness whereof I the said Joseph Pinchin the Testator have to this my Will contained in three sheets of Paper to the last sheet hereof set my hand and seal this twenty ninth day of January in the year of our Lord One thousand eight hundred and twenty five \_ Joseph Pinchin
