Commonwealth War Graves Headstone for Pte P W Amoore / Haywood is located in Front Row Grave Plot # 3 of Compton Chamberlayne Cemetery

Philip Walter Rendell Amoore was born in Ballarat, Victoria in 1875 to parents Harriet & Albert Hastings Amoore. He was a Station Hand (Boundary Rider), married & aged 41 years & 7 months from Carlton, Victoria when he enlisted on 22nd June, 1916 with the 58th Infantry Battalion, 6th Reinforcements of the Australian Army. He enlisted under the name of Philip Walter **Haywood**, with a service number of 2675 & his religion was Church of England. His next of kin was listed as his wife – Mrs Olive Haywood of 34 Barry Street, Carlton, Victoria.

Pte Haywood embarked from Melbourne HMAT *Nestor (A71)* on 2nd October, 1916 & disembarked at Plymouth, England on 16th November, 1916.

Reinforcements were only given basic training in Australia. Training was completed in training units in England. These were located in the Salisbury Plain area in the county of Wiltshire.

Pte Haywood was admitted to the Hospital at Hurdcott on 8th December, 1916 with Bronchitis & then admitted to the Hospital at Fovant on 14th January, 1917 from 15th Training Battalion.

Pte Philip Walter Haywood died of pneumonia at the Military Hospital at Fovant at 1.15 p.m. on 3rd February, 1917. A death for a Philip W Haywood, aged 42, was registered in the March quarter, 1917 in the district of Wilton, Wiltshire. (Fovant was a parish in the district of Wilton).

Pte Haywood was buried in Compton Chamberlayne cemetery on 7th February, 1917.

A letter to the Army Pay Master from Mrs Olive Haywood, dated 27th February, 1917 states that "Pte P W Haywood and I were not married although we lived together for four years and would never have separated only he was afraid that he would be forced to go to the front so he went at his own free will".

Olive Kate Haywood, defacto wife of Pte Haywood/Amoore 2675 was granted £2 War pension per fortnight from 9/4/1917. Ellen Margaret Amoore, widow of Pte Haywood/Amoore was also granted £2 War pension per fortnight from 9/4/1917. Rita Maie Amoore, daughter, was granted £1 per fortnight War pension, Kathleen P Amoore, daughter, was granted 15/- per fortnight War pension & Leonard Rendell Amoore, son, was granted 10/- per fortnight War pension. Mrs Harriet M Amoore, mother of Pte Haywood/Amoore, claim for a War pension was rejected as dependence was unproven & her claim was withdrawn.

On 18th June, 1918, at Victoria Barracks, Melbourne – Ellen Margaret Amoore, of 5 Willow St, Essendon, Victoria, signed a Statutory Declaration that she was "the wife of the soldier who enlisted as no 2675 Pte Philip Walter Haywood & that his correct name is Philip Walter Amoore. I am not acquainted with Mrs Olive Haywood who is shown on the soldier's attestation papers as

next-of-kin. I desire that his name be amended on the records and my name shown as next-of-kin".

On 28th June, 1918 Officer in Charge of Base Records informed AIF Headquarters in London that "documentary evidence has now been producedthe above named soldier enlisted under an assumed name, his correct name being Philip Walter Amoore & that his wife Ellen Margaret Amoore of Essendon is his next-of-kin". Army internal letter dated 12th April, 1921 confirms that "pensions have been granted to Mrs E M Amoore as deceased's widow & to three children in her care."


A letter to the Army, dated February 17th, 1919 from Harriet M Amoore – deceased soldier's mother- requests that the name on her son's grave be altered. She states he enlisted under the name Haywood but she is "very anxious to have the name altered to his own" – P W Amoore.

An internal Army letter, dated 29th April, 1919 confirms that the records are being amended in order that the true baptismal name of Philip Walter Amoore may be substituted for the assumed name of Philip Walter Haywood. Instructions have been given for a new cross to be erected showing the deceased soldier's correct name.

A letter dated 27th April, 1921, between Army Headquarters states that "Mrs E M Amoore, the widow of the late No 2675 P W (Haywood) Amoore, will apply for the medals." "The de facto wife is untraceable".

Pte P W Haywood was entitled to British War Medal only as he did not enter a Theatre of War. A Memorial Scroll (November, 1921) & Memorial Plaque (in the name Philip Walter Haywood) were sent to the Administrator of Estate of E M Amoore (deceased wife of deceased soldier) to be given to Leonard Amoore - son-(January, 1923).

Private P W Amoore (served as Pte Haywood) is commemorated in the Hall of Memory Commemorative Area at the Australian War Memorial, Canberra, Australia on Panel 165.

Amoore – Died 3rd February, 1917 on active service, at Fovant Military Hospital, Phillip Walter, the beloved son of Hastings and Harriet Amoore, Ascotvale; affectionate brother of Harry, Frank, Jack, Joseph, Mrs Garmonsway, Mrs Fraser, Violet Amoore, husband of Ellen Amoore; father of Rita, Kathllen, Lennie; loved nephew of Mrs Robertson, Ararat.

Commonwealth War Graves Commission Headstones

The Defence Department, in 1920/21, contacted the next of kin of the deceased World War 1 soldiers to see if they wanted to include a personal inscription on the permanent headstone at Compton Chamberlayne Cemetery. Space was reserved for 66 letters only (with the space between any two words to be counted as an additional letter) & the rate per letter was around 3 ½ d (subject to fluctuation).

The expense in connection for the erection of permanent headstones over the graves of fallen soldiers was borne by the Australian Government. (Information obtained from letters sent to next of kin in 1921)

Pte Haywood/Amoore does have a personal inscription on his headstone.
