manner and fform following I give devise and begueath to Jane the now Wife of John Large now of Craford Street Montagu Square London Paper Hanger Ten Pounds of good and lawful Money of Great Britain To Ann the now Wife of John Heughs now of Pound Pill in the Parish of Corsham in the County of Wilts Labourer for her Care and kind Attention to me Twenty Pounds of good and lawful Money of Great Britain To William and Charles Mizon who are both if living now serving in the Portsmouth Division of Marines thirty pounds each if living at the time of my Decease but if dead then my Will and Meaning is that the said thirty pounds if either of them should be dead or the Sum of Sixty Pounds if both should be dead to be equally divided between Daniel Sumpsion Mary Godwin the now Widow of Jeremiah Godwin James Mizen Mary Saloman the now Wife of Isaac Saloman all of Monkton ffarleigh in the County of Wilts and to the aforesaid Ann the Wife of John Heughs now of Pound Pill in the Parish of Corsham in the said County of Wilts share and share alike and my Will is that all the above Legacies be paid as soon as conveniently can be after my Decease Also I give devise bequeath and desire that my Dwellinghouse and Premises thereunto belonging situate lying and being Number thirty seven Stafford Place Pimlico and my Dwellinghouse and Premises thereunto belonging situate at Number thirteen Saint James Clerkenwell both in the County of Middlesex be sold and disposed of by my Executors hereinafter named for the most Money that can be got either by Public Auction or otherwise at their discretion together with three hundred pounds Stock in the Three P Cents reduced Annuities to be likewise sold out to the best Advantage together with my two Shares and two Pounds since advanced (bearing Interest at five Pounds P Cent) of the New Brewery Golden Lane Barbican London to be likewise sold to the best Advantage and all the above mentioned Premises Stock and Shares be converted into Money as soon as convenient after my Decease and to be equally divided between the before mentioned David Sumpsion Mary Godwin James Mizon Mary Saloman and Ann Heughs Share and Share alike together with any other Property belonging to me at my Decease after Paying all my just Debts and ffuneral Expences And Lastly I do nominate constitute and appoint Thomas Phillips now living at number 31 Little Moorfields London Bricklaver and Builder and John Heughs now of Pound Pill in the Parish of Corsham Labourer to be my joint Exors of this my last Will and Testament ratifying and confirming this to be my last Will and Testament contained in two Sheets of Paper to the first Sheet I have in the Presence of the Witnesses who have hereunto subscribed their Names set my Hand and to the last Sheet have set my Hand and Seal this Sixteenth Day of March in the Year of our Lord One thousand eight hundred and thirteen Darviel Gay
