This is the last Will and Testament of me Mary Painter of the parish of St Marys in Cricklade in the County of Wilts Widow Imprimis I give and bequeath unto my Daughter Mary Painter all the ffurniture belonging to the East Chamber my Clock the Scrd and in the Kitching the ffurnace in the Brewhouse The Bell mettle Pott in the Wall near adjoining to the ffurnace and also the Bed in the Chamber over the Kitching with all that belongs to the Same Item I give and bequeath unto my Daughter Elizabeth Painter all the ffurniture in the Chamber over the Kitching (except the Bed and appurtenances) I also give her the Dozen of Cane Chairs in the Parlour and two ffeather beds with the appurtenances Item I give and bequeath unto my Sister Anne the Wife of Packer of in the County of The sume of Ten pounds to be paid by my Executrixes hereinafter named within Six months next after my decease Item I give and bequeath unto my Neece Anne the Wife of John Lawman of the sume of Ten pounds to be payed within Twelve monthes next after my Decease Item I give and bequeath unto my Nephew Nicholas the Son of my late Brother William Hardham Deceased One Guinea And to his Sister Elizabeth the wife of Broockes one Shilling to be paid within Six months next after my decease Item I give and bequeath unto my Said two Daughters Mary and Elizabeth All my Right and Title given or Disposed unto me by the Last Will and Testament of my late Husband Richard Painter of in and to all the Lands Tenements and Hereditaments to me therein and thereby Devised To be held unto them and their heirs for ever But in Case either of them my said Daughters Shall Dye without Issue then and in such Case my Will is that the Same premises Shall go and Descent unto the Survivor of them my said Daughters and to the Heirs of Such Survivor of them for ever And my ffather will is that in Case Such Survivor Shall have no Issue that then and in Such Case my Said Surviving Daughter Shall have power to Dispose of the Said premises in Such manner as She Shall think fitt Item I give and bequeath unto my Sister in law Elizabeth Carterett One Guinea to buy her a Ring Item all the Rest and Residue of my Reall and Personall Estate not herein and hereby before bequeathed I Give and Dispose of the Same unto my Said Two Daughters equally to be divided between them Share and Share alike whom I make Joint Executrixes of this my Last Will and Testament And I do hereby Appoint my Brother in Law Mr Henry Cartwright Mr Richard Birt and Mr Edmund Clarke Overseers of this Will Desiring them to See the Due Execution thereof to each of which my said Trustees or Overseers I Give One Guinea to buy them Rings And I Do hereby Revoke all former and other Wills by me heretofore made In Witness whereof I the Said Mary Painter have to this my last Will and Testament Contained in One Sheet of Paper Sett my hand and Seal this Tenth Day of Aprill in the Sixth Year of the Reign of our Sovereign Lord George of Great Brittain ffrance and Ireland King Defender of the ffaith etc. Annoq Domini 1720 *Mary Painter*
