I Give to my Daughter in law Kathrine Ody the Wife of Thomas Ody the Elder of Dantsey the Sum of ffifty Shillings to be paid her by my Executor here after named in four year next after my Decease

I give all my right and Title of a peice of ffreehold given to me and my Heires by my Son Reuben Skuse Decd which said peice of Land was given to the said Reuben Skuse by his uncle Reuben Skuse the Elder of Dantsey Decd if Anne the daughter of the said Reuben Skuse the Elder should happen to dye without Issue of her body then I give all my right and Title to my son Richard Skuse and his Heirs for ever

Also my Will and meaning is that if my Daughter in law Kathrine Ody should dye before the said money should become payable then I give the said ffifty Shillings to my Grandson Ruben Skuse the son of my son Richard Skuse

All the rest residue and remainder of all my Goods chattels and Psonal Estate whatsoever not herein before given I give and bequeath unto my son Richard Skuse whome I do make and Ordaine to be my Executor of this my last Will and Testamt In Wittness whereof I have hereunto Sett my hand and Seal this 18 day of November 1727
