In the name of god Amen the 19th day of October 1600 I Joane Fursby of Weeke in the parish of Downton being sick of body but perfect of memory doe make this my last will and Testament in manner and form Following First I give and bequeath my soul unto Almighty God my maker and Redeemer and my body to be buried in the Church or Churchyard of Downton First I give to the parish Church of Downton 2 s[hillings] Item I give unto my son William 5 li [pounds] and one pair of sheets to be delivered within one quarter of a year after my decease Item I give unto three of my Williams Children 20 s[hillings] a piece to be paid at the age of 21 years or at the day of marriage Item I give unto his son John one heifer Bullock Item I give Annis my daughter one bed that I did use to lye on with the Clothe there unto belonging And also my wearing apparel and a quarter of wheat and a quarter of Barley the barley and wheat to be delivered when he shall Come to his living Item I give to John Kinge her son one heifer Bullock and to her other three daughters 10 s[hillings] a piece to be paid at the age of 21 years or at the day of marriage Item I give to John Bowden 20 s[hillings] Item I give to each of his three Children 10 s[hillings] a piece Item I give to Mary Axeford 20 s[hillings] Item I give to Roger Fursby my son Thomas his son one heifer Bullock Item I give to my son Thomas his daughter one Bullock if either of these Children happen to die before these things be due there then it shall remain to the brothers and sisters of the same to be equally divided Item I give to each of my god Children being kin to me a Ewe sheep a piece and to the rest 6 d a piece the rest of all my goods and Chattels moveable and unmoveable not given and bequeathed I give to Thomas my son whom I do make my full and whole Executor of this my last will and Testament And I do appoint to be my overseers John Puxton and Rowland Fursby to see that this my will and Testament be performed Jone Fursby mark In the presence of Robert John Eastman and Rowland Fursby
