In the name of God Amen The fifth day of September in the yeare of our Lord God 1615, and in the Thirteenth yeare of the Raigne of our Sovereigne Lord James by the yeare of God King of England France and Ireland And of Scotland the Nyne and fortieth Defender of the faith Er. I Morris Buckland of Standlynch in the countie of Wilts esquire beinge sicke in body but in perfect mynde and memory and understanding Doe make and ordaine this my present last Will and Testament in manner and forme followinge, First and about all I do bequeath and betake my Soule unto Allmightie God beserching him of his infinite goodnes and mercy to receive the same, Item I geve and bequeath unto the poore five poundes at the disposition of Anthony Foster esquire my brother in lawe, Item I gyve and bequeath unto my Servante Half a yeares wages more then their due, Item I gyve and bequeath unto Constance mt eldest daughter the some of

fower hundred pounds of currant English money to be paid unto her at her day of marriage or at her full age of one and Twentie yeares which first shall happen, then I gyve and bequeath Eleanor Buckland my youngest daughter fower hundred poundes to be paid unto her at her day of Marriage or at the full age of one and Twentie yeares which first shall happen, Item my desire and will is that the portions here by me gyven to my said daughters be imployed to their best benefitts and behoofe in any lawfull and conscionable course that the encrease and benefitt thereof shall goe and be imployed to their use by my Executor and shall be paid them at the tyme and tymes aforesiad, Item I gyve and bequeath unto Walter Buckland gent my sonne and hence all the residew of all my goods and chattells whatsoever, Item I make and ordeyne my said brother in law Anthony Foster esquire my full and whole Executor Item I make and ordeyne my brother Walter Buckland gent And my said sonne Walter Buckland my overseers, In Witness whereof I have here unto sett my hand and seale the day and yeare above written Mr Morris Buckland, his marke.
