On Wednesday was married to Mr Robert Collier, grocer, of Durrington, to Mrs Pearce, of this city.

On Thursday was married, at St. George's Church, Hanover-square, London, George Moore, Esq. of Durrington, in this county, to Miss Rhodes, of Henley-upon-Thames.

On Thursday was married, at Andover, Mr Wm. Deare to Miss Martha Weeks, of Durrington, near Amesbury.

(Salisbury and Winchester Journal - Monday 15 February, 1808)

On Monday last was married, at Durrington, Mr Thomas Lawes, of Durrington, to Miss Dowling, daughter of the late Mr Dowling of Durrington Mill.

On Tuesday last was married, Mr Lawrence Worthy, of Market Lavington, to Miss Jane Fowle, of Durrington (Salisbury and Winchester Journal – Monday 21 September, 1818)

On Monday se'nnight was married, at West Lavington, Mr Charles Smith, carpenter and joiner, of Durrington, to Miss Ann Mead, of the above place.

Tuesday last was married, at St. Thomas's Church, Mr Robert Collier, of Durrington, to Sarah, only daughter of Mr J. Bracher, salesman, of this city.

On Thursday last was married, at Amesbury, Mr Smith, of Durrington, to Miss Williams, late of Quidhampton.

Married, on Thursday, the 7th inst., at West Lavington, in this county, Mr John Smith, of Durrington, to Miss Rebecca Chandler, of the former place.

Married, on the 11th inst., at Durrington, Mr Thos. Rawlins, to Miss Jane Toomer, both of the same place.

(Salisbury and Winchester Journal – Monday 20 February, 1832)

Married, on Thursday last, at St. Edmund's Church, Mr John Smith, of Durrington, in this county, to Deidimiah, eldest daughter of Mr Kaines, of Anstey, Dorset.

(Salisbury and Winchester Journal - Monday 11 November, 1833)

Married, on the 22d inst., at Durrington, in this county, by the Rev. Mr Webb, Mr Carter, to Miss Oram, both of that place.

(Salisbury and Winchester Journal - Monday 26 May, 1834)

Married, on Saturday, Nov. 1, at Durrington, by the Rev. Mr Webb, Mr Hicks, of Amesbury, to Sarah, second dau. of the late Mr Clift, of the former place.

(Salisbury and Winchester Journal – Monday 3 November, 1834)

Married, at Durrington, May 11, by the Rev. Richard Webb, Mr Woodroff, to Sarah, the eldest daughter of Mr John May, land-surveyor, of the above place.

(Salisbury and Winchester Journal - Monday 20 May, 1839)

Married – Oct. 10, at Durrington, by the Rev. R. Webb, Mr David Rawlens, second son of Mr John Rawlens, cattle-dealer and butcher, to Sarah, eldest daughter of Mr Jos. Robert Hillary, of Amesbury, and grand-daughter of the late Mr Joseph Hillary, solicitor, of Salisbury.

Married, on Thursday last, the 22d inst., at All Saints' church, Southampton, by the Rev. J. E. Shadwell, Mr George Tabor, of Berwick St. James, to Caroline, youngest daughter of the late Mr Wm. Clift, of Durrington.

Married – June 25th, at St. Michael's, Highgate, by the Rev. Henry Fowle, M.A., George Pearce Moore, esq., of Durrington, in this county, to Mary Jane, only daughter of Henry Bloxam, esq.

(Devizes and Wiltshire Gazette - Thursday 27 June, 1844)

Married – On the 9th instant, at All Saints, Southampton, by the Rev. Doctor Almack, George Thompson, esq., of Southampton, to Sarah, eldest surviving daughter of the late William Clift, esq., of Durrington, Wilts, and relict of William Hicks, esq., of Amesbury.

Married, at St. Pancras church, London, on the 7th inst., James, the second son of Mr John May, surveyor, of Durrington, Wilts, to Harriott, the only daughter of the late Mr Wm. Bruce.

DEATHS

On Monday last died, William Fowle, Esq. of Durrington.

(Salisbury and Winchester Journal - Monday 23 May, 1803)

On Sunday the 22d inst. died, after a lingering illness, which he bore with Christian fortitude, Mr Henry Dowling, of Durrington, aged 56 years, universally respected and lamented by his family and aquaitances.

(Salisbury and Winchester Journal – Monday 30 November, 1807)

On Sunday the 18th of June died, in London, Miss Moore, only daughter of Jonathan Moore, Esq. of Durrington, in this county.

(Salisbury and Winchester Journal - Monday 3 July, 1809)

On Saturday the 24th ult. died at Durrington, Jonathan Moore, Esq. in the 77th year of his age.

(Salisbury and Winchester Journal - Monday 2 February, 1818)

On the 2d inst. died, at Durrington, sincerely lamented and regretted by her relatives and friends, Mary Jane, wife of Henry Bloxam, Esq. of Aldersgate-street, in the city of London.

(Salisbury and Winchester Journal - Monday 11 September, 1820)

Died – Lately, at an advanced age, Mr John Rombold, for a number of years schoolmaster at Durrington. He was an honest man in all his dealings, and was much respected.

(Devizes and Wiltshire Gazette - Thursday 20 November, 1823)

Died - On Thursday last, Miss Dowling of Durrington, sister of Mr W. Dowling of Enford Cottage, in this county, aged 69 years.

(Devizes and Wiltshire Gazette - Thursday 23 June, 1825)

Died - On Friday last at Durrington, after a short illness, Elizabeth, relict of the late Geo. Moore, Esq.

(Devizes and Wiltshire Gazette - Thursday 4 August, 1825)

On Tuesday last died, after a long and painful illness, which she bore with the greatest patience and resignation, Mrs S. Smith, wife of Mr William Smith, of Durrington, near this city.

(Salisbury and Winchester Journal - Monday 6 February, 1826)

Died – On Friday the 17th inst., after a short, but severe illness, borne with Christian fortitude and resignation, Mr Clift, of Durrington, whose irreparable loss will be lamented by his disconsolate widow and family.

(Devizes and Wiltshire Gazette - Thursday 23 February, 1832)

Died, at Durrington, Sept. 24, in his 87th year, Francis Rumbold, for 45 years clerk of that parish. Within a few weeks of his death he could chime two bells at once in good time, and read without spectacles.

(Salisbury and Winchester Journal - Monday 2 October, 1837)

Died, July 3, at Durrington, after a long illness, borne with fortitude and resignation to the Divine will, Mr Joel Rowden, aged 61.

(Salisbury and Winchester Journal - Monday 9 July, 1838)

Died – Oct. 18, at Durrington, Miss Smith, after a long and painful illness, borne with the greatest fortitude and resignation.

(Devizes and Wiltshire Gazette - Thursday 24 October, 1839)

Died, June 6, at Durrington, deeply regretted, Thomas Knackstone W. E. Moore, youngest son of the late George Moore, Esq., aged 28.

(Salisbury and Winchester Journal - Monday 14 June, 1841)

Died – Aug. 7, at Bucklebury, Berks, Elizabeth, the beloved wife of Mr John Pike, and the eldest daughter of the late Mr Wm. Clift, of Durrington, Wilts.

(Devizes and Wiltshire Gazette - Thursday 19 August, 1841)

Died, on the 16th inst., after a short illness, Joseph Spredbury, aged 72, an honest and industrious labourer for nearly sixty years on the same farm at Durrington.

(Salisbury and Winchester Journal - Monday 21 February, 1842)

Died, on Sunday, the 26th ult., at Landford, after a long and painful illness, Mr Amor, formerly of Durrington, a man whose strict integrity and honourable conduct secured the respect and regard of all who knew him.

(Salisbury and Winchester Journal - Saturday 4 March, 1843)

Died – On the 2nd instant, at Durrington, Mrs Elizabeth Spredbury, aged 67 years, much respected by numerous relatives and friends. – Also Mrs Sarah Lawes, aged 88 years.

(Devizes and Wiltshire Gazette - Thursday 14 March, 1844)

Died, Nov. 19, at Durrington, Jane, the beloved and only child of James and Martha Carter, aged nine years.

(Salisbury and Winchester Journal - Saturday 30 November, 1844)

Died, on Monday last, at Durrington, Mr Henry Cozens, aged 52, sincerely beloved and deeply regretted by his family, and respected by all who knew him.

(Salisbury and Winchester Journal - Saturday 13 December, 1845)

Died, at Durrington, on Sunday, the 1st inst., Mr William Hayden, aged 76 years. He was much respected by all who knew him. (Salisbury and Winchester Journal - Saturday 14 November, 1846) Died, on the 9th inst., at Southampton, aged 21, of rapid consumption, four days after landing from the West Indies, Henry Charlton, Lieutenant in her Majesty's 7th Royal Fusiliers, youngest son of W. J. Charlton, Esq., late of Rochester, and nephew of the Rev. Richard Webb, of Durrington, Wilts. (Salisbury and Winchester Journal – Saturday 14 August, 1847)
