This is the last Will and Testament of me Ann Jones of Earl Stoke in the County of Wilts Spinster made this seventeenth day of December in the year of our Lord one thousand seven hundred and fifty four First Imprimis I give and bequeath unto William Gillingham of Rattlesden in the County of Suffolk the Sum of twenty Pounds of lawful money of Great Britain (the same to be paid into the Hands of John Stovell of Grovners Street London Cheesemonger in Trust for his use) Item I give unto the said Mr Stovell ten Pounds of like lawful money of Great Britain Item I give unto Joseph Axford (son of Henry Axford of Earl Stoke aforesaid) the Sum of one hundred Pounds of lawful money of Great Britain the same to be paid him when he comes to the Age of one and twenty Years and all Interest as my Executrix herein after named can make thereof my Will and desire is to be paid out during his Minority for and towards his Schooling and Education and not otherwise But

in case he dies before comes to the Age of one and twenty Years then I give the said hundred pounds equally between his Brothers and Sisters as shall then be living Item I give unto Jane Axford Daughter of the said Henry Axford all my Bedding Linnen my Wearing Apparel Pictures and China and Gold Rings Item I give unto Mrs Hannah Emes of Earl Stoke aforesaid five Pounds of British money Item I give unto Mary Lacy Daughter of Ann Lacy of Stoke aforesaid two Guineas and my two mourning Gowns And as for all the rest of my Goods Chattels Credits and Personal Estate whatsoever and wheresoever after my funeral Expences Legacies and Debts are discharged and paid I give and bequeath the same unto Jane Axford Wife of the aforesaid Henry Axford whom I do nominate constitute and appoint my full and sole Executrix of this my last Will and Testament and I do hereby revoke disannul and make void all former Wills by me at any time made In Witness whereof I the Testatrix Ann Jones hath to this my last Will and Testament mentioned and contained in this Sheet of Paper set my Hand and Seal the day and year within mentioned *Anny Jones*
