Death Item: I give and Bequeath unto my Loving Wife Jane Hulbert all my household Goods Moneys Security for Moneys Stock of Cattle Crop of Corn Grain Hay and all other my Goods and Chattles whatsoever and wheresoever which I shall be Seized or possessed of at the time of my Death Subject and Chargeable with the Payment of my Debts Leagacies and funerall Expences And I do hereby make constitute and appoint my said Wife whole and sole Executrix of this my last Will and Testament, if itt shall so happen that my Wife Jane do out lieve me but if itt shall please God that my wife Jane should Die before me then all and Every particular thing or things whatsoever Either within or without dores I do give to my Daughter Elizabeth New and my Daughter Ann Kinger Equaly to be parted between them whome I do make my Joynt Executrixes of this my last Will and Testament they performing my Will as is above mentioned, In Witness Whereof I the said Jacob Hulbert have hereunto sett my hand and seal the Day and Year first above Written The Marke of Jacob X Hulbert
