At a View of Frank Pledge with the Court Barron of Robert John Buxton and Henry Stephens Esquires Farmers of the Provoost and the College Royal of the Blefsed Mary of Eton near Windsor in the County of Bucks Lords of the Manor aforesaid there held on Wednesday the Tenth Day of October in the Thirty second year of the Reign of our Sovereign Lord George the Third by the Grace of God of Great Britain ffrance and Ireland King Defender of the ffaith and soforth and in the Year of our Lord One Thousand seven Hundred and Ninety two before Daniel Clutterbuck Gentleman Steward.

At this Court the Lords of the Manor a foresaid by the Steward aforesaid before the somage according to the custom of the said Manor granted unto Adam Bullock of Hullavington aforesaid Yeoman the Reversion of One Messuage or Tenements and one Yard Land and one quarter part of a Yard Land with the Appurtenances there unto

belonging formerly in the Pofsefsion of John Bullock and part of the Customary Lands of this Manor now in the tenure of the said Adam Bullock and Jacob Bullock his brother who hold the same for the Life of John Bullock by virtue of a certain Copy of Court Roll heretofore granted thereof **To have and to hold** the Reversion of the said Mefsauge or Tenement and all and singular other the Premises with the Appurtenances unto the said Adam Bullock for and during the Lives of Daniel Sargent now aged about Fourteen years and Isaac Sargent now aged about Eleven Years Sons of John Sargent of Grittleton in the said County of Wilts Yeoman and the Life of the longest Liver of them at the Will of the Lords according to the Custom of the said Manor when by Death Surrender or forfeiture of the Estate of the said John Bullock for whose Life it is held by the said Adam and Jacob Bullock by a certain Copy of Court Roll of the said Manor bearing date the Twenty second day of October One Thousand seven hundred and Eighty nine or by any other ways or means the Premises aforesaid shall happen to fall into the Hands of the Lords Paying therefore yearly Five Shillings and Six Pence and an Herriott when it shall happen and paying and doing all other Rents Duties and Services therefore one and of right accustomed And for such Estate to be had in the Premises the aforesaid Adam Bullock hath paid to the Lords a Fine as by Agreemant and was Admitted Tenant in Reversion but his Fealty was respited until and soforth.
