In the Name of God Amen The Nineteenth day of July in the seventh yeare of the Raigne of our Sovraigne Lady Queene Ann of Great Brittain etc. Annoq Dm 1708 I Mary Gawen of Hullavington in the County of Wilts Spinster being in pfect health and Memory thanks be to Almighty God for it but minding my Mortality Doe make this my last Will and testament in Manner & forme following That is to say ffirst I bequeath my soule into the hands of Almighty God my Creator hoping hereafter to have A Joyfull resurrection and my body to the earth from whence it was taken to be buried in Decent Manner as for my worldly estate which the Lord hath lent me I dispose of as followeth Impris I give and bequeath unto my Cosin Sarah Smith wife of John Smith the younger of Hullavington aforesaid Cordwainer One hundred pounds of lawfull English money to be paid unto her within Twelve moneths after my decease And I give more unto my said Cosin Sarah Smith ffoure brass pans ffoure brass kettles and one bell mettlet pott Six pewter platters one pewter Candlestick one pewter flagon two pewter dishes one Chest standing in the Parlor one standing bedsteed standing in the Chamber over the Hall my best feaver bed my best coverlett one paire of Canvas sheetes one paire of new blanketts one feather bolster & bolster cases and one paire of Curtaines & Vallings and one sett of Curtaine rodde And I give and bequeath unto my Cosin John Bullock sonne of Adam Bullock deceased ffive pounds of lawfull English money to be paid unto him by my Executrix hereafter named within Twelve moneths after my decease And I give and bequeath unto my ffoure Cosens Sarah Gawen William Gawen Joyse Gawen and Martha Gawen ffourty shillings a peece being the money I lent unto my Kinsman William Gawen their father of Oldbury upon the hill to be paid unto them by their said father ltm I give unto my said Cosen William Gawen the elder of Oldbury upon the hill one shilling And I give unto my Sister Martha Wallis of Porbury in the county of Somsett Widdow one shilling Item all the rest of my goods Chattles and Cattle unbequeathed I give unto my Sister Sarah Bullock of Hullavington aforesaid Widdow Whome I make my whole and sole Executrix of this my last Will And I doe nominate and appoint John Smith the elder of Hullavington Cordwinder and Isaac Cottle of the Sem Hullavington yeom Overseers of this my Will to see it in all things well and truly pformed And for their paines taken therein I give unto them One shilling a peece And all other Wills by me formerly made I doe utterly revoke and publish my last the mke of Mary Gawen
