This is the last Will and Testament of me Edward Dismore the Elder of Hungerford in the County of Berks Carpenter first I desire that all my just debts funeral and testamentary charges and expences to be paid by the Executor and Executrix of this my will I give and devise unto my daughter Ann Dismore all those Cottages or Tenements Gardens and Premises situate and being in the Down Pits Hungerford aforesaid To hold the same unto my said daughter Ann Dismore for and during the term of her natural life free from the control debts or engagements of any Husband she may hereafter marry

also I give unto my said daughter Ann Dismore all my leasehold Cottage or Tenements Gardens and Premises with the appurtenances situated and being on the north Side of the Grate Church Lane in Hungerford aforesaid for and during of her natural life free from the control debts or engagements of any Husband she may hereafter marry I also give and bequeath unto my said daughter Urania Smith the Wife of George Smith the sum of fifty pounds also I give unto my said daughter Sarah Dismore the sum of fifty pounds I also have given unto my said son Edward Dismore all the freehold Tenement and premises situate on the south side of the Grate Church Lane in Hungerford aforesaid and now in his own occupation also the fifty pounds he have in hand immediately after my decease I also give and bequeath unto my said daughter Ann Dismore the sum of one hundred pounds now in the hands of Mr George Smith for and during the term of her natural life after her decease to be equally divided between my said Grandchildren Amelia Spicer the Wife of William Spicer Carpenter in the Parish of Lambourn George Challis Ursula Challis Edward Challis Ann Challis and William Dismore otherwise Miller the son of my said daughter Ann Dismore also I give and bequeath all my freehold Tenements Gardens and Premises situate and been in the Down Pits aforementioned and also all my leasehold Cottages Tenements Gardens and Premises situate and being on the North Side of the Grate Church Lane in Hungerford as aforementioned after the decease of the said Ann Dismore to be equally divided between my said Grandchildren share and share alike I also give to my daughter Ann Dismore all my household goods and furniture all the rest residue and remainder of my real and Personal Estate and Effects whatsoever and wheresoever I may die possessed of and lastly I do hereby nominate constitute and appoint my said Grandson Edward Challis and my said daughter Ann Dismore joint Executors of this my last Will and Testament hereby revoking and making void all former and other Wills by me at any time heretofore made and I do declare this only to be my true last Will and Testament In Witness whereof I have to this last Will and Testament contained in two sheets of paper set my hand and seal the fourteenth day of february in the Year of our Lord one thousand eight hundred and thirty one Edward Dismore

Also I hereby give and bequeath unto William Dismore the Son of the late James Dismore of Hungerford in the County of Berks the sum of one shilling *Edward Dismore*

(Personal Appearance by Ann Dismore daughter of the deceased on 29 August 1831 as to validity of Codicil; deceased died on 12 July 1831; on 14 February 1831 Elizabeth Spicer wife of William Spicer Granddaughter of deceased wrote the Will at the dictation of the deceased)
