

Andover Union To Butchers, Bakers, Millers Grocers, and Others Contract For Provisions, &c.

The Guardians of this Union are desirous of receiving Tenders for the supply of the Union Workhouse, at Andover, from 21st day of March next to the 20th Day of June next, with Bred, Flour, Oatmeal, Butcher's Meat, Bacon, Boiling Peas, Tea, Sugar, Butter, Cheese, Milk, Candles, Wood, Soap, Beer, and other articles of consumption usually required in Workhouses; also, with good Seconds Bread, at 4lb loaf, and Flour, at per gallon, for any one or more of the undermentioned Out-Relief Districts of the above Union, for the same period: that is to say:-

- No. 1. **Andover District**, comprising the parishes of Andover, Appleshaw, Knights Enham, Foxcott, Penton Mewsey, and Penton Grafton.
- No. 2 **Hurstbourne Tarrant District**, comprising the parishes of Chute, Chute Forest, Hurstbourne Tarrant, Faccombe, Tangley, Linkenholt, and Verham's Dean.
- No. 3 **Longparish District,** comprising the parishes of Abbots Ann, Bullington, Barton Stacey, Chilbolton, Goodworth, Clatford, Longparish, Upper Clatford, and Wherwell.
- No. 4 **Ludgershall District**, comprising the parishes of Amport, Fifield, Grately, Kimpton, Ludgershall, Monxton Quarley, Shipton, Tidworth North, Tidworth South, and Thruxton.

The several articles for the Workhouse to be delivered in such quantities and at such times as the Master shall require: and the Bread and Flour for the Out-Relief Districts to be delivered at such time, and in such quantities and places, as the relieving Officer shall direct. No articles will be received except such as shall be approved of by the Master of the Workhouse, or the Relieving Officer.

The Tenders, sealed and directed to the Chairman of the Andover Union, and marked "Tender for ______." To be delivered (accompanied by samples of all convenient articles) at the Union Workhouse, Andover, on or before ten o'clock in the forenoon of Saturday, the 14th day of March next, after which hour no Tender will be received.

Security for the due fulfilment of the Contract must be provided, at the expense of the Contractors. Forms of Tender may be had on application to me, at my Office, in Andover, and in no other form will the Tender be received.

N. B. - All Bills on the Union must be delivered at my office on or before the 21st day of March next, or they will not be included in the present quarter's accounts.
