Will and Testament in manner and forme following First I begueath my Soule into the hands of Almighty God my Creator hoping to be found by the m.... of Jesus Christ my Saviour and Redeemer And my body to be buried in Christian buriall As for my worldly goods I dispose in manner and forme following Imprimis I give and bequeath unto my daughter Anne one Coffer Item I give unto my daughters Alice and Magaaret all my Lynnen to be equally devided bitween them and unto each of them one silver spoone Item I give unto my sonne Jasper one silver spoone and the Gould ring that was his father's Item I give unto my sonne William one silver spoone Item I give unto my sonne Hugh All my household stuffe that is not already hereby bequeathed With this proviso that if my sonne William when hee shall come unto the age of one and twenty yeares shall give sufficient Securitie unto the Executors of this my last will and testamentfor the ... payment of the sum of Ten pounds of lawfull money of England unto his said brother when he shall come unto the age of one and twentie yeares then imediately upon security given as aforesaid, the said houshold stuffe shall be wholely my Sonne William's for ever And if my sonne Hugh shall decease before he come to age of one and twentie yeares Then my will and meaning is that my sonne William shall be quit and discharged from the payment of the said Tenn pounds Item I give unto my sonne Hugh fortie pounds to be paid unto him by my Executor when he shall come unto the age of one and twentie yeares And if he shall happen to decease before he come unto the age of one and twentie years Then the said fortie poundes shall be paid unto my sonne William Item I give unto my sister Elizabeth Watts my best Gowne Item I give unto my brother Robert White And unto loveinge freind John Woodward of Ludgershall five shillings apeece whom I de require to be Overseers of this my will And all the rest of my goods and chattles I give unto my brother John White Whom I doe make Executor fully and wholely of this my last Will and Testament Desireing him that when my debts and legacies and my funerall rites and other accidentall Charges are satisfied he will out of the remaynder of my goods (here to him bequeathed) give and allow unto such of my children as my Overseers shall declare to have most neede soe much respectively as my Overseers shall think fitt In witness whereof I have hereunto put my hand and seale the eight and twentieth day of the month of July in the yeare of our Lord One Thousand Sixe hundred and fifty foure The marke and seale of Alice Mundy
