This is the Last Will and Testament of me Jane Legg of Market Lavington in the County of Wilts Spinster I give and bequeath unto Thomas Hellier Son of the late Susanna Hellier deceased the sum of three Guineas I give and bequeath unto my Brother the Revd Joseph Legg of Urchfont in the said County of Wilts Clerk the Sum of one hundred Pounds to be paid to him within one year after the decease of my Sister Mary Legg of Market Lavington aforesaid spinster and as to all the rest residue and remainder of my Estate and Effects of what nature or kind soever and wheresoever the same may be after payment of my Debts and ffuneral Expences and subject thereto I give devise and bequeath the same unto my said Sister Mary Legg for and during the term of her natural life and after the decease of my said Sister Mary Legg I give

devise and bequeath the same unto my Sister Elizabeth Palmer Wife of the Reverend John Palmer of ffordington in the County of Dorset Clerk her Heirs Executors Administrators and Assigns for ever And I do hereby nominate and appoint my said two Sisters Mary Legg and Elizabeth Palmer Executrixes of this my last Will and Testament hereby revoking all former Wills by me at any time heretofore made In Witness whereof I the said Jane Legg have to this my last Will and Testament set my hand and Seal this first day of June in the Year of our Lord One thousand eight hundred and four *Jane Legg*
