In the Name of God Amen I Mary Dixon of Marlborough in the County of Wilts Widow being weak in Body but of sound and disposing mind memory and understanding Do make and ordain this my last Will and Testament in manner and form following that is to say ffirst I will and direct that all my just Debts ffuneral and Testamentary Expences be fully paid and satisfied and after payment and satisfaction thereof Then I give and bequeath unto my Son Robert Dixon & my friend John Brown of Marlborough aforesaid Banker And to the Survivor of them And to the Exors or Admors of such Survivor the Sum of Three hundred and ffifty pounds of lawful British Money But upon this Special Trust and Confidence (that is to say) Upon Trust that they my said Trustees or the Survivor of them or the Exors or Admors of such Survivor do pay or cause to be paid the said Sum of Three hundred and ffifty pounds unto my Grand Daughter Mary Ann Brown so soon as she shall attain the Age of Twenty one Years for her Sole and separate use her Heirs and Assigns for ever All the Rest and Residue of my Money Goods Chattels Securities for Money Estate and Effects of what nature or kind soever or wheresoever I give and bequeath unto my son Robert Dixon his Heirs and Assigns for ever And my will is and I do hereby direct that the receipt of my said Trustees or the Survivor of them or the Exors or Admors of such Survivor shall be a good and sufficient discharge for any Money that he or they may receive by virtue of this my Will And also that it shall and may be lawful to and for them my said Trustees or the Survivor of them or the Exors or Admors of such Survivor to reimburse himself or themselves respectively all such Costs Charges Damages and Expences as he or they or either of them shall bear sustain expend or be put unto in the execution of the Trusts in them reposed or in any ways relating thereto And I do

hereby make nominate Constitute and Appoint my said Son Robert Dixon Executor of this my last Will & Testament hereby revoking and making void all other Will and Wills by me at any time heretofore made and do declare this and this only to be my last Will and Testament In Witness whereof I the said Mary Dixon have to this hereunto set my hand and seal this twenty third day of July One thousand eight hundred and nine Mary Dixon X her mark
