In the name of God Amen I Richard Dismer of Marlborough in the County of Wilts Parchment maker being sick and weake in body but of sound and perfect mind and memory thanks be given to God for the same Doe make and ordaine this my last Will and Testament in manner following that is to say ffirst I commend my soule to God that gave it and my body to the earth hoping assuredly for a joyfull resurrection of the same through the alone merits of Christ my Saviour and as touching such worldly estate as it hath pleased God to blesse me withall I give and dispose of the same as followeth Inpris I give and devise unto Dorothy my loveing Wife my now dwelling House in Oxford Street in the parish of St Mary the Virgin in Marlborough aforesaid with all Outhouses Backsides Gardens and Appurtenances thereunto belonging and all my Land with the appurtenances in Kingsbury Street in Marlborough aforesaid To hold the same for the terme of her naturall life and after her decease I doe give and devise the same Lands Tenements and appurtenances unto Robert Butcher late of Marlborough aforesaid Chandler for the terme of fforty yeares thence next following In trust only that he the said Robert Butcher his Executors Administrators or Assignes shall and will out of the cleare yearly rents issues and profitts of the said Lands and Tenements raise the sume of forty pounds of lawfull moneyto be paid to my two daughters Elizabeth and Mary

their Executors and Assignes equally as the same can be raised And my will and meaning is that after the said forty pounds shall be raised out of my said Lands and paid aforesaid that then the said terme of forty yeares shall cease and the same Lands to returne and descend to my eldest sonne and Heire at Law and his Heires for ever And I give my eldest sonne Richard one shilling And I doe hereby constitute and appoint my loveing Wife Dorothy Dismer sole Executrix of this my last Will and Testament Thirty first of March one thousand six hundred eighty six The marke of Richard Dismer Signed sealed and published in the presence of John Blagford H: Wall Joseph Hockley
