In the name of God Amen The eighteenth day of April in the year of our Lord God one thousand six hundred and eight I Wynifrith Francklen in the parish of St Peter and St Paul the Apostles in Marlborough widow do ordain and make this my last will and testament in manner of form following First I bequeath my soul to Almighty God my maker trusting to be

saved only by the merit death and passion of Jesus Christ his son my Redeemer And my body to be buried in the church of Saint Peter's beforesaid Imprimis I give and bequeath to the poor people of Saint Peters in Marlborough twenty shillings after my decease Item I give to the poor of east Kennett six shillings Item I give to the poor of Buckleaze six shillings

Item I give to the church of Sarid twelve pence Item I give to the church of Saint Peters in Marlborough six shillings Item I give to Mr Doctor Feyld to preach my funeral sermon twenty shillings Item I give to the six younger sons of John Folwell of Well street in the parish [of] Buckleaze forty one pounds to be paid within six months after my decease viz that the two youngest sons to have their portion at the age of twenty one years The beforesaid forty one pounds to be equally divided amongst them And the four oldest of the six sons to have the use of it until the two younger come to the full age of twenty one years Item I give to Henry Folwell the son of William Folwell five pounds to be paid within six months after my decease Item I give to John Francklin of Overton six pounds to be paid within six months after my decease Item I give and bequeath to Cicely Wells Richard Wells and Marye Wells the children of my daughter Margaret Hichcocke one hundred pounds which my son Richard Francklen of East Kynnett does owe upon bond to the said Testatrix to be paid within one year next after my decease by the said Richard Francklin The said hundred pounds to be equally divided between the said Cicelye Richard and Marye Wells Item all such debts as Willm Jumper of Norrington my son-in-law did owe unto me the said Testatrix I do frankly and freely forgive the said Willyam Juniper My will is that my Executors shall make and give unto William Jumper my son-in-law aforesaid for me and in my name a gold ring of the value of forty shillings wherein shall be set four letters for the name of the said Testatrix And the said William Jumper to be paid within three months after my decease Item my said Executors shall give for me and in my name the like ring to my said son-in-law Richard Francklin of Kynnett with four letters for my name and the said Richard Francklen to be delivered within three months after my decease Debts owing unto the said Testatrix follow: Imprimis Richard Francklen my son in-law of East Kynnett does owe unto the said Testatrix for a year and a quarters rent due at our Ladies Day last fifty pounds Item Anne Popejoye of Overton widow does owe unto the said Testatrix upon a bond forfeited of twenty pounds for the payment of ten pounds ten pounds Item John Brownejohn does owe four score and ten pounds of principal debt upon a bond whereof the said Testatrix has received twenty pounds three score and ten pounds Item the said John Brownejohn owes more unto the said Testatrix four pounds Item Robt Folwell of Buckleaze owes upon a bond of forty pounds ten pounds Item moreover the said Robert Folwell owes forty shillings All the residue of my goods and chattels moveable and unmoveable not given nor bequeathed my debts and legacies paid and my funeral expenses discharged I give and bequeath unto Richard Hichcocke my son-in-law and to my daughter Margaret his wife whom I do ordain and make my whole Executors of this my last Will and Testament jointly and to perform it according to the true meaning of the said Testatrix Item I do constitute and appoint overseers of this my last Will and Testament to see it truly performed Phillipe Francklin of Marlborough and John Chapman also Hiscock of Preshute and for their pains taken therein I give unto them ten shillings apiece
