William Mill, of Minety, Gloucestershire, Yarn-maker

Richard Lawrence, of Minety, Grocer.

Salisbury and Winchester Journal 3 May 1819

The Creditors who have proved their debts under a Commission of Bankrupt awarded and issued forth against RICHARD LAWRENCE, late of Minety, in the county of Wilts, grocer, shopkeeper, dealer, and chapman, are desired to meet the Assignees of the Bankrupt's estate and effects on the 24<sup>th</sup> day of February next, at eleven o'clock in the forenoon, at the White Hart Inn in Tetbury, in the county of Gloucester, to assent to or dissent from the said Assignees commencing, prosecuting, or defending any suit or suits at law or in equity, for recovering of any part of the said Bankrupt's estate and effects; or to the compounding submitting to arbitration, or otherwise agreeing any matter or thing relating thereto; and on other special affairs. Dated this 27<sup>th</sup> day of January, 1820.

Gloucester Citizen 7 April 1881

Samuel Haggard, carpenter, of Minety, applied to the court for an administration order. He handed to his Honour a schedule of his debts. Upon being asked if this was all, he said there was £11 10s owing for rent. Applicant said he had been married 12 years, and had got seven children, and had just buried one. He attributed his loss to bad trade and not being able to sell goods when made up. He thought of offering his creditors 2s 6d in the £. He thought they would take it.

In answer to his Honour, applicant said he had just got into work, and offered to pay 6s per month.

His Honour said: Why should I make an order to deprive your creditors of their money? The offer you make would take eight years to pay off your debts and costs. His Honour further added if his creditors were willing to take 2s 6d in the £, he would make an order, but as there were no creditors present he should adjourn the case for a month, in order to give some of them a chance to appear.

Western Daily Press 12 July 1888

Samuel Haggard appeared before the court on an adjourned application for an administration order. The case was adjourned from the last court to enable some of the creditors to attend, but none now appeared. The debtor offered 2s 6d in the £, payable in monthly instalments of 6s, but the judge described the offer as ridiculous, and refused the application.

Western Daily Press 17 August 1888

Charles Lane, Flisteridge Road, Minety, Wilts, farmer and grocer, but now out of business.

Bath Chronicle and Weekly Gazette 9 January 1908

Harry Harrison, Braydon Hall, Minety, Wilts, gentleman farmer.

Western Daily Press 14 January 1925

George Hender Job, of Silver Street, Minety, Wilts, schoolmaster, out of employment.
