#### WORKMEN'S COMPENSATION CASE

Mr Kimber (of Messrs Bradford and Co, solicitors, Swindon), made an application to the County Court (Judge Ellicott) in respect of the administration of the sum of £150 available from the Sun Commercial Union on the death by accident of Jesse Marshall, at Wootton Bassett, in June last. The deceased had been employed by Mr Walter Clark, of Common Farm, Minety, and died as the result of an accident.

His daughter and only dependent, Charlotte Marshall, gave evidence, and said she did a little charring and nothing else. She wished the Judge to make an order for £10 down in respect to funeral and other expenses, and 12s a week to herself. Mr Clark suggested that 10s a week would be sufficient, but it appeared the applicant was nearly destitute.

His Honour made the order for £11 (£1 for the girl's immediate needs) and 11s a week, to be paid monthly, the residue to be invested.

Mrs G P Mullings, Cirencester

Mrs Georgina Poppaea Mullings, of Cirencester, widow of Mr John Mullings, who died on January 3<sup>rd</sup> last, aged 84 years, left gross estate of the value of £22,152 8s 0d, with net personalty £18,456 6s 2d.

Edith Elizabeth Mullings, of the same address, spinster, daughter, and Richard John Mullings, of the same address, solicitor, son, are the executors. The will is dated May 30<sup>th</sup> 1921.

She left her jewellery etc., equally between her daughters, her household effects to her children in equal shares, the Manor of Minety to her son Richard John Mullings, and the residue of the property as to £2,000 upon trust for her daughter Mrs Ida Mary Brooke, and such a sum as will make up to £3,250 each with sums already given to her unmarried daughters, and the remainder to her five sons or their issue of deceased in equal shares.

Mrs Elizabeth Isabella Oliver, of The Mansells, Minety, Wilts, and Yealscombe, Exford, who died on August 27, widow of William Oliver, left estate of the gross value of £14,969 with net personalty £9,371. Probate has been granted to Col Edward Griffith Dickson, of Higher Farm, Seaborough, Crewkerne, and Alfred William Chubb, of Malmesbury, solicitor.

Testatrix left £1,000 each to her three children; £5 to Nurse Taylor; £50 per annum to her late husband's niece, Cora Olivia Chichester; a few other small legacies; and the residue of the property in trust for her adopted daughter, Elizabeth Owen Blackwood, for life with remainder to her children, or their issue, whom failing to the testatrix's children or their issue equally.
