I Ann Jones of Minety in the County of Gloucester Spinster, do make and declare this writing to be my last Will and Testament in manner and form following. That is to say

I give and Devise unto Mr Robert Peacey of Chudglon in the County of Wilts all and singular my Property of every Description and Dependency In Trust for the following person or persons and to be applied in and after the following manner or manners, Viz,

Whereas I had the sum of One hundred Pounds of Lawful British Money left me By the last Will and Testament of my Aunt Hall and likewise the sum of One hundred Pounds by the last Will and Testament of my uncle John Keene both which Sums are Deposited in the Hands of my Uncle Mr William Keene of Minety in the County of Gloucester now my Will and desire is that as soon as Conveniently after my Decease my Funeral expenses shall be paid by my said Trustee and I do give and Devise to my Mother the sum of Ten Guineas to purchase some Remembrance of me, And I do give and Devise

to my Sister Frances Perry the sum of Two Guineas to purchase a Ring in Remembrance of me all the rest and Residue of the above Sum of Two hundred pounds I give and Devise to my Sister Sarah Elizabeth Turner.

Also I give and Devise to my Sister Sarah Elizabeth Turner all rights and Title of Inheritance in the Property of my late Father, And I like wise give and Devise to my Sister Sarah Elizabeth Turner all right and Title of Inheritance in the Property of my Mother, All which I give to my said Sister in such manner that neither her present Husband or any future Husband shall have any thing to do with either the said Sums, And all sums that may be given to me by Bequests and all Expectancies that I may have Any rights and Title to Receive, I give and Devise the same to my Sister Sarah Elizabeth Turner in the manner above mentioned.

Also I give and Devise all my Clothes and wearing apparel to my Sister Sarah Elizabeth Turner, And I do nominate and Appoint my Sister Sarah Elizabeth Turner to be the sole Executrix of this my last Will and Testament.

In Witness there of I have here unto set my Hand and Seal this twenty Eighth Day of December in the year of Our Lord One thousand eight hundred and Twenty.
