This is the last Will and Testament of me John Peuple Yeoman of the parish of Minety in the County of Wilts and Gloucester, being of sound Mind, Memory, and Understanding do make Publish and declare the same in manner and form Following,

that is to say in the first Place I revoke and make void all former Wills by me at any time heretofore made, I will and direct that all my just debts and funeral expenses, and expense of Proving this my will be Paid by my executor hereinafter named, within Twelve months next after my decease and subject thereto, I give devise and bequeath to Thomas Brown of Minety aforesaid, In Trust for the use of my Children all my real and Personal Property of whatever denomination it may consist of to be equally divided between them share and share alike (namely) John Peuple, Jonathan Peuple, William Peuple, Sarah Packer, Ann Huse, Frances Armon, Rebecca Daniels, Mary Musty, and Jane Packer all my Sons and

Daughters. Next the said Thomas Brown, his executors or administrators shall divide and apply all my Real and Personal Property as before directed, thereby nominate, constitute and appoint the said Thomas Brown Sole executor of this my will. In witness whereof the said John Peaple the Testator have hereunto subscribed my hand and affixed my seal this twenty eighth day of August one Thousand eight Hundred and forty Six

Appeared personally Thomas Brown of Minety in the County of Gloucester Farmer and alleged upon oath that this paper writing contains the true original last Will and Testament of John Peaple late of Minety aforesaid deceased who died on the 31st day of August 1846 leaving Goods Chattels Credits wholly within the Jurisdiction of the Consistory Court of Gloucester under the values of Four hundred and fifty pounds That he is the sole Exor. therein named That he will well and faithfully perform the same and render an Inventory and account
