I Mary Warren the wife of Joseph Warren of Minety in the County of Gloucester Gentleman late Mary Powell Spinster do hereby in pursuance and exercise of the power and authority given and reserved to me in and by a certain Indenture of Settlement dated the twentieth day of November one thousand eight hundred and twenty seven made previous to my marriage with the said Joseph Warren and by force and virtue of all and every the power and powers authority and authorities in me being or enabling me thereto make my last Will and Testament in manner following (that is to say)

I give and bequeath unto my Brother William Powell the sum of one hundred pounds but in case of his decease during the lifetime of my husband then I give the same to be equally divided between the children of the said William Powell

I give and bequeath unto my Brother Thomas Powell the sum of one hundred pounds but in case of his decease during the lifetime of my said husband then I give the same to his wife Mary and daughter Rachael their executors administrators and assigns equally to be divided between them

I give and bequeath unto my Brother Joseph Powell the sum of fifty pounds but in case he shall depart this life in the lifetime of my said then I give and bequeath the said sum of fifty pounds to the children of my Brother William Powell

I give and bequeath unto my Sister Rachael the sum of fifty pounds

I give and bequeath unto the children of my late Sister Oliffe the sum of ten pounds apiece

I give and bequeath unto all the children of my brother William Powell the sum of ten pounds apiece

All the Rest Residue and Remainder of my Estate and Effects which I have a right to dispose of I give and bequeath unto my said Brothers and Sisters their executors administrators and assigns equally to be divided between them

And I do hereby nominate constitute and appoint my Nephew William Son of my said Brother William Powell sole Executor of this my Will In witness whereof I have hereunto set my hand and seal this twenty sixth day of January one thousand eight hundred and thirty one

Proved at London 1st April 1851 before the Judge by the oath of William Powell the Nephew of the Deceased Son of her Brother a William Powell the sole Executor to whom Admon was granted Limited so far only as concerns all the right title and interest of the said Deceased in and to all such personal Estate and Effects as she the said Deceased by virtue of a certain Indenture of Settlement bearing date the 20th Nov 1827 has a right to appoint or dispose of and hath in and by her Will appointed or disposed of accordingly but no further or otherwise he having been first sworn (by commission) duly to administer.
