In the Name of God Amen. I Phillip Timbrel of Minty In the County of Gloucester Labourer Revoking any former Will or Wills do make and ordain this writing to be my last Will and Testament in manner and form following that is to say

I give and Bequeath unto my Son Robert the House he now lives in commonly called or known by the name of Legge House. I likewise give my son Robert the Clock that is upstairs and one great Chair

I Give and Bequeath unto my son Phillip the sum of Fifty Pounds of good and lawfull money of great Britain I like wise give him the Clock that is in the Kitching and one great Chair –

I give unto my son Robert a large Table that is up stairs –

I give to my Son Phillip the Bed and Bedding I now lay on –

and my Will and desire is that my Two Sons shall at lady day next If it so happen that I should die sell and dispose of the Cattle that are designed for sale and pay all Rents and Taxes and divide the Residues of the money arising from such sale betwixt them equally –

as to the Rest and Residue of my Stock of Cattle Hay Household goods and Property of every description I give to my sons Robert and Phillip to be equally betwixt them – but If they cannot agree to part it them selves I order and Direct that the aforesaid property shall be valued by Two persons one Son to chuse one person and the other another and then my Sons shall chuse the things they wish to have Robert to make the first choise of one article and Phillip the next and so continue In Turn or Rotation till they have taken to the whole according to the Value as valued by some persons as aforesaid and my Will and desire is that my Two Sons have the use of my Cart betwixt them Jointly as they may happen to want it –

and there are five Pewter Plates that are marked P.T. I order and Direct my Son Phillip to have them

I give to my Son Roberts Daughter Dianna a Large Trunk and all things that are in it – and I do here by Constitute and appoint my Sons Robert and Phillip Executors of this my last Will and Testament - my Will and Desire is that my Son Robert shall have the Land called White Hays and the Breaches and my Son Phillip to have the Land I now Rent of Mr Parsloe

I witness whereof I the said Phillip Timbrel have here unto set my hand and seal the Twenty fourth day of February In the Year of our Lord One thousand eight hundred and six

Edward Cooke, Master of Arts, Vicar General in Spiritual of the Honourable and Right Reverend Father in God Henry, by Divine Permission Lord Bishop of Gloucester, and of his Episcopal Consistory Official Principal lawfully constituted, to our beloved Christ Henry Anthony Pye and Henry Cripps, clerks.

Greetings, We do by these Presents commit our Power and Authority to you, jointly and severally (in whose fidelity we fully confide), to receive the corporal Oath, of Robert Timbrell and Philip Timbrell the Sons and Executors named, of and in the last Will and Testament of Philip[Timbrell late of Minety in the County and Diocese of Gloucester, Labourer deceased, well and faithfully to perform the said Will, and also to exhibit an Inventory, and render an Account according to the Tenor of the under-written Oath;

And what shall be done in the Premises by Virtue of these Presents, Ye shall duly certify the same to us, our Surrogate, or some other competent Judge in this behalf, together with these Presents, and the said Will hereunto annexed, on or before the last Day of November next otherwise this Commission to be void and of none Effect. Given under the Seal of our Office, this twenty eighth Day of October One Thousand Eight Hundred and eighteen.

The Oath

You Do severally Swear, that you believe the Paper Writing, hereunto annexed, contains the original last will and Testament of Philip Timbrell late of Minety in the County and Diocese of Gloucester, Labourer deceased; That you are the Executors therein named; That you will well and faithfully perform the said Will, by first paying the Debts of the said deceased, and then the Legacies in the said Will mentioned, so far as the Goods, Chattels, Rights and Credits of the said deceased will thereto extend and the Law charge you; that you will exhibit into the Registry of the Lord Bishop of Gloucester, a true and perfect Inventory of all and singular the Goods, Chattels, and Credits of the said deceased, and render a just and true Account of your Administration thereof. When lawfully required so to do. You do also swear that the personal Property of the said deceased, at the Time of his Death, did not amount in Value to the Sum of Two hundred Pounds.
