I Thomas Jenner of Netheravon in the County of Wilts hereby revoke all testamentary dispositions by me heretofore made and declare this to be my last Will and Testament I devise all my freehold lands tenements and hereditaments situate at Marston Mazon in the said County unto my Nephew Thomas Jenner (son of my sister Hannah) his heirs and assigns I bequeath to my sister Anne the Wife of John Scammell the sum of ten pounds and to my Nephew Daniel Henry Jenner the sum of ten pounds I bequeath the sum of two thousand and five hundred pounds to such child or children of my late deceased brother John Jenner as have attained or shall attain the age of twenty one years if more than one to be equally divided between them and whereas I am entitled to a copyhold estate at Marston Masey aforesaid which is held for my own life and for the life of my said Nephew Daniel Henry Jenner whose life was put in by me for his own benefit but in order to avoid all question in relation thereto I do hereby bequeath the same and all other my copyhold lands tenements and hereditaments situate at Marston Masey aforesaid unto my said Nephew Daniel Henry Jenner absolutely and subject to the payment of my debts and funeral and testamentary expences I devise and bequeath all my freehold lands

tenements and hereditaments situate at Manningford Bohune and Hurst in the said County of Wilts and all my freehold and copyhold lands tenements and hereditaments situate at Durrington in the said County and all other my real and personal estates property and effects whatsoever and wheresoever and of what nature tenure or quality soever unto my brother Henry Jenner his heirs executors administrators and assigns and I appoint my said brother Henry Jenner and my said Nephew Thomas Jenner Executors of this my Will In Witness whereof I have hereunto subscribed my name the fifth day of December one thousand eight hundred and fifty six \_ *Thomas Jenner*
