1859	David Tulley	One month for hawking without a license at Oaksey. Devizes and Wiltshire Gazette Thursday 16 June 1859	
1866	William Anderson	One month for vagrancy at Oaksey Devizes and Wiltshire Gazette Thursday 20 December 1866	
1869	William Rigsby	One month for bastardy at Oaksey Devizes and Wiltshire Gazette Thursday 25 November 1869	
1872	Elizabeth Mayo	10 years of age, living at Oaksey, was brought up on remand charged with stealing a pair of calico drawers, the property of Simon Lewis, of Poole Keynes, on the 3 rd ult. Fined £1 (under the Juvenile Offenders Act), which was paid. Western Daily Press Friday 12 January 1872	
1872	William Morris	Seven days for vagrancy at Oaksey. Devizes and Wiltshire Gazette Thursday 27 June 1872	
1873	Thomas Wicks & Frederick Glass	Charged with being drunk and fighting, at Oaksey, on Sunday, the 23 rd of February. The case was proved by PS Perrett. Fined 9s each, including costs. Western Daily Press Friday 7 March 1873	
1873	Charles Jones	A hawker, was charged with being drunk and refusing to quit the Wheatsheaf Inn, at Oaksey; and also with being drunk and riotous at the same time and place. Fined 10s 6d in each case, including costs. Western Daily Press Friday 4 July 1873	
1873	James Wainwright	Was summoned to show cause why he should not contribute towards the support of the illegitimate child of Elizabeth Harris , of Oaksey. Western Daily Press Friday 8 August 1873	
1873	Jesse Fisher & William Uzzell	Of Oaksey, charged with being drunk and riotous, were fined 13s each, costs included. Western Daily Press Friday 5 December 1873	
1873	Mark Rickets	Charged with refusing to leave the Wheatsheaf Inn, at Oaksey, when requested, was fined 13s, costs included. Western Daily Press Friday 5 December 1873	
1874	George Rickets	Of Oaksey, was brought up in custody of PC Oatley, charged with being drunk and riotous, and refusing to leave the public street, at 11 o'clock on the night of the 20 th instant. PC Oatley deposed that he found the prisoner very drunk, and making a noise in Gloucester Street, when he requested him to go home, which he refused to do. He then took him into custody. Prisoner admitted the offence, and was convicted and fined 5s and costs. Swindon Advertiser and North Wilts Chronicle Monday 26 January 1874	
1875	Hannah Darve	Of Oaksey, a girl about 14, was brought up in custody of PS Perrett charged with stealing a box containing money, the principal part of which consisted of farthings. Remanded until the 4th of August. Swindon Advertiser and North Wilts Chronicle Monday 26 July 1875	
1877	George Chambers	A lad twelve years of age, was charged with willful damage to a plough. Mr Charles Warner, a farmer, of Oaksey, said that on the last day of January the	

plough was left all right, and the next morning the ploughman found the plough all in pieces, and some of it broken. The lad said he took it apart to put it together again, but could not do so. The chairman said he ought to be whipped, but as he had no father, he would be fined 12s, including costs.

Western Daily Pres s Friday 9 February 1877

1877 John Mills

Of Oaksey, pleaded guilty to a charge of drunkenness at Crudwell, and likewise with riding in a waggon without reins. Fined 2s 6d and 8s 6d costs.

Western Daily Press Thursday 5 April 1877

John Collar & Richard Collar

Two brothers, of Swellbrook, Minety, aged 14 and 16 respectively, were summoned by John Leonard Hawkins, farmer, of Oaksey, for doing damage to a gate by unhinging it and throwing it in a pool. The case was proved by George Butcher and PS Cross. The defendants had been drinking at Oaksey, until nine o'clock on the Sunday night, and the damage was alleged to have been committed on their way home. The Bench informed the defendants that they were liable to a fine of £5 each, but as this was their first offence, they would be fined in the mitigated penalty of £1 each, including costs , or one month each. The money was paid .

Swindon Advertiser and North Wilts Gazette Monday 10 December 1877

1878 F Fisher

Of Oaksey, for being drunk and disorderly at Crudwell, was fined 1s and 9s costs.

Swindon Advertiser and North Wilts Gazette Monday 8 April 1878

1882 Walter Baker

A native of Oaksey, but who has been living at Birmingham, was brought up in custody charged with stealing a silver watch, two jackets, and a pair of trousers, value £2, the property of his father, Daniel Baker, labourer, at Oaksey, on the 10th inst. The prisoner paid his father a visit, and he was afterwards apprehended at Cirencester with the property in question in his possession. He was remanded until Friday.

1883 Henry Taylor & Noah Ody

(Taylor appeared but Ody did not). Farmers, were summoned by Supt Luffman, charged with removing two pigs from a sale at Oaksey, without a license. Taylor admitted the offence, but stated that he acted in accordance with an advertisement in a Wiltshire paper, which he produced. He did not think he was violating the law. The bench believed he acted in perfect good faith, but they must inflict a fine and costs, which would amount to £1 5s 6d.

Devizes and Wiltshire Gazette Thursday 8 March 1883

1888 Sarah Williams

Domestic servant, was charged with stealing a gold ring, value £5, the property of her mistress, Miss Hannah Buckland, of Woodfold Farm, Oaksey. She was sentenced to 14 days' hard labour.

Bristol Mercury Monday 10 September 1888

1889 Stewart Ricketts

Single man, of Oaksey, was charged by Albert Kent, landlord of the Wheatsheaf Inn, with being quarrelsome and abusive to him, and refusing to leave his house on the 25th December. Plaintiff proved the case, and defendant pleaded guilty, but said that it was the plaintiff's beer that made him quarrelsome. Fined 11s, including costs.

Devizes and Wiltshire Gazette Thursday 3 January 1889

1890 Arthur Wright

A carter, of Oaksey, was summoned by Charles Mayo, an under carter, on a charge of beating him with a stick on 23rd Nov. Plaintiff stated that defendant beat him on the head , throat and back for no offence whatsoever. Defendant admitted beating him, but said he did not do it cruelly. The lad was lazy and did not come to his work, and was saucy. Fined 13s 6d including costs.

Devizes and Wiltshire Gazette Thursday 4 December 1890

1891 William Whiteman

A single man, carpenter, residing at Oaksey, was summoned by Albert Kent, landlord of the Wheat Sheaf Inn, Oaksey, charged with refusing to quit licensed premises when requested, on the 29th November last; there was a second charge of assaulting and beating the landlord. The bench decided to hear both cases together, and ultimately fined the defendant 25s, to include costs, and allowed three weeks to pay.

1897 Clara Watts

Of Oaksey, fined 8s in respect of unmuzzled dog.

Swindon Advertiser and North Wilts Chronicle Saturday 20 November 1897

1898 Matilda Butcher

17, a well dressed, decent, respectable looking servant girl, surrendered to her bail, and pleaded guilty to breaking and entering the dwelling house of Daniel Biggs, at Oaksey, on the 10th November, and stealing a £5 note, £1 18s, and other articles. Three months' hard labour.

Bristol Mercury Wednesday 5 January 1898

1899 Kate May

17, of Oaksey, was charged with sleeping out and having no visible means of subsistence. The police gave the girl a very bad character, and Supt Morgan intimated that further efforts would be made to reform her. She was sent for seven days' hard labour.
