Church Matters

1851

Preferment: The Rev H Barne, MA, Curate of Seend, Wilts, to the Vicarage of Faringdon, with the Curacy of Little Coxwell, Berks. Patron's Simeon's Trustees. Wells Journal Saturday 27 December 1851

1852

The Rev Henry Barne, late Curate of Seend in this county, has been appointed a Surrogate for the diocese of Oxford. Salisbury and Winchester Journal Saturday 20 March 1852

Preferment: the Rev E A Brooks to the Curacy of Seend, Melksham, Wilts. Cheltenham Chronicle Thursday 20 May 1852

1855

The Rev William Collins Badger, Clerk, MA, has been licensed by the Lord Bishop of Salisbury to the Curacy of Seend, in the parish of Melksham in the county of Wilts. Salisbury and Winchester Journal Saturday 9 June 1855

1857

The Rev William Guidott Sealy, MA, formerly curate of Seend, near Melksham, for many years, has been presented by the Lord Chancellor to the Rectory of St Lawrence, in the city of Winchester, void by the resignation of the Rev E Woodcock. **Devizes and Wiltshire Gazette Thursday 29 October 1857**

1858

Church Bequest --- The late Thomas Jefferies, gentleman, of Seend, left by will to the Church Missionary Society £100. Devizes and Wiltshire Gazette Thursday 5 August 1858

1860

Annual meeting of the Wilts Church Missionary Association. --- (extract) --- The Rev Mr Badger of Seend also rose to plead the claims of the Society, and took occasion to remark that in that village there were twenty eight annual subscribers to the Church Missionary Association, while at Devizes alas! There were but 3. **Devizes and Wiltshire Gazette Thursday 21 June 1860**

1863

Diocese of Salisbury. --- His Lordship licensed the Rev James Sanderson Serjeant, Clerk, MA, to the Curacy of Melksham and Seend, Wilts. **Dorset County Chronicle Thursday 31 December 1863**

1867

On the 26th ult the Lord Bishop of Salisbury licensed the Rev Allan Ifill Pile, clerk, MA to the curacy of Seend. **Dorset County Chronicle Thursday 7 March 1867**

1869

The following have been instituted and licensed by the Bishop of Salisbury.... The Rev Frederick Gough to the curacy of Seend. Western Gazette Friday 17 December 1869

1873

The vicarage of Seend, Wilts, having recently by order of the Queen in Council been separated from the vicarage of Melksham and constituted a separate benefice, the Bishop, on the nomination of the Dean And Chapter of Salisbury, has licensed the Rev A B Thynne to the living. Western Gazette Friday 7 November 1873

1890

We hear that the Rev A B Thynne, of Seend, has been offered the living of Melksham, but the rev gentleman has not stated whether he will accept the offer. **Devizes and Wiltshire Gazette Thursday 19 June 1890**

1894

The Rev A B and Mrs Thynne of Seend have been presented by the parishioners with a service of plate in recognition of their silver wedding. **Bath Chronicle and Weekly Gazette Thursday 4 October 1894**
