

Steeple Langford Swayne family Obituaries

On Thursday se'nnight died, in the 60th year of his age, after a long and painful illness, which he bore with the greatest fortitude, Mr. Swayne, of Steeple Langford; a man of the strictest honour, integrity, and economy; and possessed of that rare virtue and private charity.

The Salisbury and Winchester Journal, 3 December 1804.

In his 18th year, Mr. Wm, Swayne son of Mr. Thomas Swayne, of Steeple Langford. **Bristol Mirror**, **30 November 1805**.

A few days since died Mr. Thos. Swayne, of Steeple Langford The Salisbury and Winchester Journal, 14 January 1811.

Died – Aged 50, Eliza Ann, wife of Thomas Swayne, Esq., of Steeple Langford, in this county. **Dorset County Chronicle, 21 September 1826.**

Died. - Sept. 8, aged 52 years, Eliza Ann, wife of Thos. Swayne, Esq. of Steeple Langford, Wilts. **Hampshire Chronicle**, **18 September 1826**.

Died – at Steeple Langford, on Friday the 10th inst., Mrs. Frances Smith, widow of the late Mr. Smith, of Devizes, and mother of Mr. John Swayne, Clerk of the Peace, Wilton. **Devizes and Wiltshire Gazette. 16 March 1837.**

At Steeple Langford, June 13th, Ann Margaret, third daughter of Mr. John Pile Swayne, of that place.

March 24, after a lingering illness, Lucy Mary, wife of Thomas Swayne, Esq., of Steeple Langford, aged 59 years, deeply lamented by her family and friends.

Death. - Oct. 23, in the 59th year of her age, Anne, the beloved wife of Mt. John Swayne, of Steeple Langford.

April 5, at Steeple Langford, Martha, daughter of John. P Swayne esq., aged 36. **Devizes and Wiltshire Gazette, 12 April 1860.**

Dec. 29, at Steeple Langford, in the 80th year of his age, Thomas Swayne, esq. Mr Swayne was one of the oldest and most respected of the farmers of Wiltshire. A more truly upright. Kind-hearted, hospitable man, not only to those of his own class, but to the poor who lived around him (and who, by his death, have lost a warm friend) did not exist.

April 17, at Steeple Langford, Wilts, after a short illness, Caroline, wife of Thomas Perrior Swayne, Esq., aged 56 years.

May 19. on board the Halcione, en route for New Zealand, Thomas Henry Swayne, second son of Th. P. Swayne, of Steeple Langford, aged 22.

Swayne, John Pile, Steeple Langford, Wilts, farmer, died June 8, 1883, Claims to Cobb & Smith, Salisbury, Sols., by July 18.
