In the name of God Amen I John ffisher of Hemmington in the parish of Stratford Tony in the County of Wiltes husbandman beinge sicke in body but sounde and perfect of remembrance thankes be given unto God Doe ordayne and make this my last will and Testament in manner and forme followinge, ffirst I give and bequeath my soule to Allmightie God my maker and my body to be buried in the Church at Hemmington and to give them vis viiid , Item I give to the mother Church of Sarum xiid, Item I give to my parish Church iis vid, Item I give to the poore of the parish of Hemmington

vis viiid, Item I give to the poore of the parish of Stratford Tony iis vid, Item I give to Androw Russell and Sisly Russell
eche of them one Chilver sheepe, More I give unto Timothy ffisher and a Cha.... dishe , I give unto every one of my god
Children iiii a peece, Item I give unto John Chitter the Minister vis viiid Item I give unto my Cossen Margaret Thorne vis
viiid Item I give unto Elizabeth Herber(?) vis viiid, Item I give unto Thomas Clarcke iis vid, I give unto ffrances Chitter one
kine, And I Doe request John Chitter and the saide Thomas Clarcke to be my Overseers of this my Will, I Doe
acknowledge and confesse I owe unto my sonne Thomas ffisher xli which I will my sonne John ffisher shall satisfie And
then all the rest of my goods moveable and unmoveable my Debts beinge paide I give and bequeath unto my two sonnes
whome I make my Executors
