The two women are neighbours, and their children having fallen out, was the cause of the pugilistic encounter between them. Both parties bound over to keep the peace. *The Salisbury & Winchester Journal 10-04-1852*.
- -Joseph COLDING, shoemaker of Stratton, for stealing an umbrella from church door, while drunk, the property of Superintendent HAYES. Fined 5s and placed in stocks for 6 hours. *The Salisbury & Winchester Journal 15-05-1852*.
- -George BOURTON for stealing some coal at Stratton. Two months gaol. *The Salisbury and Winchester Journal 03-07-1852.*
- -Elizabeth SEYMOUR, beerhouse keeper of Stratton fined £1 for encouraging drinking, smoking and singing, at 2 o'clock in the morning. *Devizes & Wiltshire Gazette 29-07-1852.*

1854 James THATCHER was fined £1 for assaulting P.C. Thatcher at Stratton. *Devizes & Wiltshire Gazette 05-01-1854*.

- -John WAKEFIELD was committed to 1-month hard labour for assaulting Sarah NEW at Stratton, and also bound over to keep the peace. *Devizes & Wiltshire Gazette 05-01-1854*
- -James REEVES for breaking into the dwelling house of Samuel JONES of Stratton and stealing coats and 4d. 4 months gaol. *Devizes & Wiltshire Gazette 05-01-1854*
- -Sarah NEW, 14 days for having assaulted John Wakefield at Stratton. *Devizes & Wiltshire Gazette* 23-02-1854
- -A Beer house keeper named KEENE was charged before the Swindon Branch of Magistrates, on Thursday last, with having permitted drunkenness and disorderly conduct in his house at Stratton, on the 26th March. -To support the charge, police-constable THATCHER thus swore: - On the night, when I heard a great shouting and bawling inside; on going in I found three men very drunk. They abused and assaulted me, and afterwards followed me out, still continuing to make use of very bad language. KEENE was present but said nothing, on the contrary, he laughed and appeared well pleased at what was going on. Mr. BROWN, who appeared on behalf of the defendant, cross-examined the witness - I undertake to swear a boy named BAKER was not there; Mrs. SMITH was nor there; on other persons but the landlord, landlady. And the three men I have named. I pulled out my watch outside of the house, I did not pull it out inside the house. The men were smoking and drinking. Mr. BROWN on behalf of the defendant, called Wm. BAKER who, in direct opposition, swore - I lodge at KEENE's beer house. I recollect the night the policeman came, the 26th of March; I was in the room. The three men were at supper: Mrs Smith was there. I was standing before the fire. Richard KEENE was not there; he went to bed at 8 o'clock. I pulled out my watch, and it was half-past nine, the policeman pulled out his and said it was half-past nine. Two of the men followed him out of the house, but they came back in ten minutes and finished their supper; the men were not drunk. In answer to a question from the bench, witness said that there was no noise or disturbance in the house before the policeman came in.- Ann SMITH corroborated BAKER's statement in every particular, and distinctly swore that the men were not drunk, and that there was no noise or disturbance in the house, and that KEENE was gone to bed when the policeman came in. On one side or the other, there must, we should suppose, be gross and deliberate perjury. It will admit of no explanation. Under the circumstances, the Magistrates dismissed the case. - -Edward JEEVES, was indicted by William LEWIS, for a nuisance over right of way at Stratton St. Margaret. *Devizes & Wiltshire Gazette 15-03-1855.*
- -Charlotte AUSTIN, for one-month Devizes Goal, for having assaulted and beat Elizabeth HARVEY, at Stratton St. Margaret. *Devizes & Wiltshire Gazette 19-07-1855*
- -Elizabeth NEW, for three weeks Devizes Gaol, for feloniously stealing a quantity of wheat in the straw, the property of Thomas ARKELL, at Stratton St. Margaret. *Devizes & Wiltshire Gazette 20-09-1855*
- -Four young women, Rose CARTER, Jane SAUNDERS, Ann EATWELL and Mary AVENALL, inmates at Union Workhouse, Stratton Sy Margaret, were charged by the master with misconducting themselves, and creating a disturbance in the Workhouse. Jane SAUNDERS was reprimanded and dismissed, and the others were sentenced 21 days' imprisonment with hard labour. *Devizes & Wiltshire Gazette 22-11-1855.*

1856 Elizabeth Collier and Sarah ADAMS, for fourteen days each, for misconduct at Workhouse, *Devizes & Wiltshire Gazette 17-01-1856.*

- -Rebecca HATHERALL, for one month, Devizes Gaol, for stealing two leather shoes the property of George DAY, of Stratton St. Margaret. *Devizes & Wiltshire Gazette 17-01-1856*
- -Burglary at Stratton St Margaret, On Monday night the dwelling-house of Mr. Horton was broken into, and the drawers of a bureau were ransacked; fortunately, one drawer which contained a large amount of money was locked and escaped being forced open. The Robert was evidently perpetrated by an inexperienced hand, and only a great coat and a few articles were stolen. *Devizes & Wiltshire Gazette 07-02-1856*.
- -W. WILLIAMS, a horse dealer, was charged by Mr. DAY of Stratton, with having rescued some horses from the road surveyor, which had been seized for impounding. The horses were injuring Mr. Day's fence, but as there appeared to be some doubt respecting the seizure, the Bench gave the defendant the benefit of the doubt, and dismissed the case, but cautioned him not to allow his horses for the future to stray along the sides of the road. *Devizes & Wiltshire Gazette 12-06-1856*.
- -Wm. BARRETT was charged with stealing hay, the property of Richard TILLEY and George TILLEY, of Stratton. The jury returned a verdict of guilty, and the prisoner was sentenced to 14 days imprisonment. The prisoner had already been 3 month in prison. *Reading Mercury 05-07-1856*.
- -On Tuesday last the Bishop of Gloucester had a confirmation in the Parish church, Swindon. A number of girls from the Stratton workhouse were confirmed, their clean appearance and neat attire attracted much attention and were highly creditable to the Guardians and the master and matron of the establishment. *Devizes & Wiltshire Gazette 23-10-1856.*
- -Thomas RIVERS, a carter in the employ of Mr. S. JONES, Stratton, was sentenced to two months hard labour, for stealing some coal from a load which he had been sent to deliver to a customer. *Devizes & Wiltshire Gazette 13-11-1856.*
- -Jas. ALLEN was charged by the police with his house open on Sunday, for the sale of beer, at Stratton. Having been recently fined for a similar offence, the Bench imposed a penalty of £3 10s, to include costs. Devizes & Wiltshire Gazette 24-12-1856.

1857 Henry EMBLING for forty-two days Devizes Goal, for stealing one cloth coat and one knife the property of Giles ANDREWS of Stratton. *Devizes & Wiltshire Gazette 26-03-1857*.

- -William BARRETT, for one-month Devizes Gaol, for rescuing cattle from the pound, at Stratton. *Devizes & Wiltshire Gazette 04-06-1857*
- -David RODERICK, for 21 days Devizes Gaol, for wilful damage in the Union Workhouse, at Stratton. *Devizes & Wiltshire Gazette 04-06-1857*

- -Reuben BEECHAY, farm servant, of Mr. Edward JEEVES, of Stratton, was brought up on a warrant, charging him with misconduct in his service in refusing properly to perform his work. Reprimanded, and ordered to pay 7s 6d costs, to be deducted from his wages. *Reading Mercury 5-9-1857*.
- -Joseph REEVES, for stealing small quantities of pulse and barley-meal, the property of Mr. Thomas ARKELL of Stratton, 6 months' imprisonment. *Reading Mercury 31-10-1857.*
- -William PINNOCK and Edward PAGE appeared to summon, charging them with being drunk and disorderly at Stratton, on the 5th Inst. They were fined 10s each and allowed a week for payment. *Reading Mercury 14-11-1857.*
- -TENEMENT ACT Thomas FISHER, of Stratton, applied for a warrant to recover possession of a cottage occupied by Thos. TITCOMBE, at South Marston. The warrant was accordingly granted. *Reading Mercury* 14-11-1857.

1858 William HASKINS, of Stratton, was charged by his master, Mr. Richard CLACK of the same place, shoemaker, with stealing 14s, his property. The case appeared very clear to the magistrate; the prisoner was committed to take his trial at the ensuing Sessions. *Reading Mercury 02-01-1858*.

- -Elizabeth NEW, of Stratton, was summoned by her master Mr. William HORTON, of that place, farmer, for stealing a quantity of apples from his orchard: she was sentenced to six weeks hard labour at Devizes Gaol. *Reading Mercury 21-08-1858.*
- -George TARRANT, of Stratton, was brought up, charged with indecent assault upon an infant child, three years of age. He was found guilty, but there being peculiar circumstance in the case, and the defendant receiving a good character, the Bench thought that they would be fully justified in migrating the penalty, and they fined him £3 14s, including costs, which he paid. *Reading Mercury 16-10-1858 & Swindon Advertiser 18-10-1858.*

1859 Maria SIMMONS, a filthy woman, for one month for vagrancy, at Stratton. Swindon Advertiser 14-02-1858 & Devizes & Wiltshire Gazette 17-02-1859.

- -Thomas MAJOR, for twenty-one days, for misconduct in the Union Workhouse, at Stratton. *Devizes & Wiltshire Gazette 24-02-1859*.
- -Solomon HALE was indicted for the manslaughter If James MINAL of Stratton. It appeared that prisoner went to Kingsdown Inn on 19th March. He was ejected from pub with two others, MINAL & BRETT (Minal's son-in-law). A fight started with Brett & Minal got involved, striking Hale, after a few minutes of fighting Minal fell to ground and died following day. Sentence having already served eleven weeks and being badly beaten, judge gave him one day. *The Salisbury & Winchester Journal 23-7-1859*
- 1860 -Henry WAKEFIELD of Stratton, summoned for being drunk in charge of waggon and 3 horses. Fined £1 including costs. *Swindon Advertiser 05-03-1860.*
 - -Mary JOHNSON, dairymaid to Mr Thomas Kirby of Stratton for leaving her service while under contract. Ordered to return and have 8s 6d deducted from wages. *Swindon Advertiser 26-03-1860*.
 - Phineas BAKER an old and inform man of Swindon charged with hawking without a licence. Committed to 14 days hard labour. *Swindon Advertiser 26-03-1860*.
 - -Joseph Henry LYTTEN, for stealing nineteen fleeces of wool, the property of Henry ELLENBOROUGH, at Stratton, was acquitted. *The Hampshire Advertiser 21-07-1860.*
 - -Elizabeth SEYMOUR, beerhouse-keeper for selling beer during prohibited hours on 8th July. Fined 40s including costs. *Swindon Advertiser 06-08-1860.*
 - -Job HUNT of Stratton St Margaret was charged with torturing and ill-treating a cat, the property of Charles Porter of New Swindon, on the 16th inst. A witness, Ann Head, said that on the afternoon of the 16th, as she was passing down the lane heading from the Red Cow beer-house to Mr Reynold's she saw the defendant with two dogs. The dogs were tearing something on the grass: the defendant stamped on it and then took it by its hind legs, when she discovered it to by Mr Porter's cat. Defendant positively denied seeing any cat, and said it was a hedgehog and not a cat that his dogs caught. The witness Ann Head was again recalled and, upon being questioned about its being a cat that she saw, said she had no doubt whatever about it she was not more than 10 yards off when Hunt held it up by its hind legs. Charles Porter said that on the 16th the cast was missed from the house and had not been seen since. Ordered to pay £1 and 11s costs. And in

default of payment to be committed for one month. Defendant, who became very abusive, said he would take the month. *Swindon Advertiser 27-08-1860.*

- -Cornelius TROTMAN and Enos TARRANT, two young men of Stratton St Margaret, were charged with assaulting Edward BARNES, of the same place, at Stratton on the 11th inst. BARNES said on the evening of the 11th, about a quarter past nine o'clock, I was going down street towards my home when James Hughes spoke to me and asked me to shake hands with him. I did so, and as I was standing talking to him Trotman and Tarrant came up to me and took hold of my person in an indecent manner and commenced pulling me about, one before and one behind me. They did me considerable injury and I was unable to attend to my work for five days. I have offered to make the matter up if the defendants would pay me 3s a day for the five days. Defendants denied the assault and said the charges had been trumped up for the purpose of extorting money. Complainant was in the habit of conducting himself in an indecent manner and, in common with others they had occasionally a game with him. It has been proved, to the satisfaction of the court, that the complainant had been guilty of indecent behaviour, the charge of assault was dismissed, and the complainant ordered to pay 7s costs. Trotman and Tarrant were bound over to be of good behaviour for six months and pay 3s 6d each costs. *Swindon Advertiser 27-08-1860*.
- -William FARMER of Stratton was charged by Mr. Edward JEAVES, surveyor of highways, for rescuing a horse from his custody when on way to pound. 14 days hard labour. *Swindon Advertiser 24-09-1860*.
- -George Taylor, for two months Devizes prison, for stealing a pair of trousers, the property of Edwin NEW at Stratton. *Devizes & Wiltshire Gazette 20-12-1860.*
- 1861 -John ROBERTS, a wandering vagrant to Devizes Gaol for 12 days. Swindon Advertiser 18-02-1861.
 - Thomas COX and wife with one child, were ordered to be removed from Stratton to Broughton Poggs, Oxon. Swindon Advertiser 18-03-1861.
 - -Charles WINKLESS was adjudged to be the father of the illegitimate child of Martha SPACKMAN and annual order made. *Swindon Advertiser 25-03-1861*.
 - -Edward BARNES charged with assaulting Maria BARNES on 13th. Fined £1 14s or 21 days in his absence. *Swindon Advertiser 29-04-1861*.
 - Mary Ann JONES, a tramp committed to 21 days hard labour for begging in Stratton. Swindon Advertiser 06-05-1861.
 - -Charles WRIGHT, Richard BARTON & James SPARKS, for using nets in the Canal. Fined £5 10s, or 3-months prison. Swindon Advertiser 17-06-1861.
 - -William WARREN & Lovedon THORN of Stratton charged with assaulting James DIX, dix having complained that Warren had been bringing women to their shared bed, so he was unable to sleep. Dismissed. *Swindon Advertiser* 29-07-1861.
 - -John BISLEY of Stratton, adjudged to be the father of the bastard child of Eliza WILKINS of Wanborough. Ordered to pay 1s 6d per week maintenance. *Swindon Advertiser* 29-07-1861.
 - -Elisabeth FLIGHT of Swindon, widow, was brought up for unlawfully disposing of a dead body of a newly born female child at Stratton St Margaret. Being seen by Richard HUNT, Constable Barrett was called and followed back to the home, where he challenged the widow and she admitted disposing of the body for a third party. Remanded for one week. *Swindon Advertiser 21-10-1861*.
 - George TOLSON, for two months Devizes prison, for leaving his family chargeable to the parish of Stratton. *Devizes & Wiltshire Gazette 14-11-1861.*
 - -Three Stratton lads for stealing swedes the property of Henry Elborough. Boys given warning and case dismissed. *Swindon Advertiser 02-12-1861*.

1862 Isaac REASON, 14 days Devizes prison, for wilfully damaging a quantity of swede turnips, the property of George POCOCK of Stratton. *Devizes & Wiltshire Gazette 09-01-1862.*

- -Thomas SMITH, fourteen days Devizes prison for vagrancy at Stratton. *Devizes & Wiltshire Gazette 23-01-1861.*
- -Thomas GIBBS, six weeks Devizes prison, for wilfully damaging a quantity of grass, the property of George REYNOLDS, at Stratton. *Devizes & Wiltshire Gazette 08-05-1862*.

- -Caroline YEATES, Francis YEATES and Edwin SELWOOD, all of Stratton, were brought up in custody charged with releasing two horses after being seized by the hayward for the purpose of being impounded. John ILES said he was hayward of the parish, and had seized the horses, and ongoing to the pound the female knocked him down, and the others drove them away. The case was dismissed, as it was proved that complainant was drunk at the time, and the Magistrates asked if he was an ale taster as well as a hayward, as he was drunk then. *Reading Mercury 28-06-1862*.
- -Christian BRITTON for assaulting Charles SMITH and his wife for abusing and assaulting other members of the family. After evidence, there appeared to be a dispute between neighbours, so defendants had to pay 12s 6d costs only. Swindon Advertiser 21-07-1862.
- -Thomas GARRETT, for fourteen days in Devizes prison, for absconding from the Workhouse with a suit of the Union clothing, and a further twenty-one days for assaulting a police officer at Stratton. Devizes & Wiltshire Gazette 30-10-1862.

1863 James DODD, for fourteen days Devizes prison, for assaulting Jane ADAMS, at Stratton. *Devizes & Wiltshire Gazette 26-02-1863.*

- -George RICKS to Devizes Prison, 6 weeks for stealing coal from Great Western Railway, Swindon. Devizes & Wiltshire Gazette 26-02-1863
- -Harriett GODWIN and Ann Farr, for three months each, and Fanny FORD for fourteen days in Devizes prison, for misconduct in the Workhouse at Stratton. *Devizes & Wiltshire Gazette* 12-03-1863.
- -William GREEN was fined 19s 2d including costs for 21 days for assaulting P C Hiscocks on 25th April. *Swindon Advertiser 11-05-1863.*

Richard MOSS, fishmonger, fruiterer, etc., surrendered to his bail with receiving a sovereign from Charles Andrews, boy of 6, for some nuts. Case dismissed but with reservations. *Swindon Advertiser 11-05-1863*.

- -Hester LAURENCE, for six weeks Devizes prison, for maliciously breaking twenty-four panes of glass in the Union Workhouse at Stratton. *Devizes & Wiltshire Gazette 02-07-1863*
- -Job HUNT, for one-month Devizes gaol, for leaving his children chargeable to the parish of Stratton. *Devizes & Wiltshire Gazette 03-12-1863.*

1864 Keziah TOLSON, for twenty-one days Devizes prison, for misconduct in the Workhouse at Stratton. *Devizes & Wiltshire Gazette 24-03-1864*.

- -Wm. Hyde was convicted of obtaining the sum of 1s 6d, under false pretences at Stratton, and sentenced to 3 months hard labour. *Devizes & Wiltshire Gazette 31-03-1864.*
- -Francis YEATES of Stratton, summoned by Mr. George Trout, beerhouse keeper of Swindon, for being drunk and refusing to leave on 11th April. Fined 17s 6d or 14 days. *Swindon Advertiser 25-04-1864*.
- -Stephen Farmer, of Wantage, hawker, charged with robbery from the person of Joseph LOOKER of Stratton. Committed for trial. *Swindon Advertiser 23-05-1864*.
- -George BRIND was charged with stealing three pieces of wool from his master Mr. JEAVES. As wool had been found behind a shared bed the case was dropped. *Swindon Advertiser* 30-04-1864.
- -Alfred CLACK of Filkins for obtaining a Great Coat in false pretences from Mrs. STROUD of Stratton. Case adjourned. *Swindon Advertiser 30-04-1864*. At the trial he was given 21 days' hard labour. *Swindon Advertiser 06-06-1864*.
- -John HUNT, charged by William COLLETT, farmer with misconduct in service. Ordered to return to work and pay 4s 6d costs. *Swindon Advertiser 20-06-1864*.
- -Elizabeth PINCOCK charged by William LOVEDAY with assaulting him on the 11th. Fined 1s and 9s costs. *Swindon Advertiser 20-06-1864.*
- -John NEW, with charged with violently assaulting Joseph WEEKS on 23rd last outside a Stratton pub. Committed for 21 days and £5 surety. *Swindon Advertiser 01-08-1864*.
- -James HATHERELL a boy of 8, charged with setting fire to a hedge the property of Mr ELBOROUGH of Stratton. Case adjourned for further enquires. *Swindon Advertiser* 15-08-1864.

- -James DIX was charged by Frederick CLACK with assaulting him at Stratton August, last year, DIX having to be brought up on warrant. Fined £1 and 14s costs or 7 days hard labour. Swindon Advertiser 15-08-1864.

- -George YEATES was charged with being father of illegitimate child of Fanny ADAMS of Stratton, usual order was made. *Swindon Advertiser 28-11-1864*.
- -Charles MORSE, for one month, for destroying game at Stratton. Devizes & Wiltshire Gazette 15-12-1864.

 - Eliza LAY & Elizabeth LAY, mother & daughter were charged with the assault of Ann GEORGE, wife of John GEORGE of Stratton. Mother fined £1 including costs, daughter discharged but told to keep out of trouble. *Swindon Advertiser 27-08-1866.*
 - -John RICHENS, for seven days, for being drunk and riotous at Stratton. *Devizes & Wiltshire Gazette 04-10-1866.*
 - -William MILLS, for six weeks, for poaching at Stratton. Devizes & Wiltshire Gazette 08-11-1866

 - -James DODD, for one month, for misconduct in the Workhouse. Devizes & Wiltshire Gazette 07-03-1867.
 - -Ann FARR was indicted for killing her infant child Jane FARR at Stratton. The child was born in the Workhouse April last year. They were admitted in Early January, the child appearing sleepy and heavy, the

mother was asked if the child had received a blow to the head but got no response. On 15th January, the nurse heard the prisoner slapping the child. The Guardians they tried to take the child, but she grabbed the child by the throat and died shortly afterwards. Sentence – Penal servitude for life. *Devizes & Wiltshire Gazette 28-03-1867*

A 50-year-old labourer was jailed for having danced on, and urinated on, the coffin of a woman who had once failed to supply him with enough beer? Thomas WATKINS, of Stratton St. Margaret, a married man with a family, had been employed to sink a well at the house built for the widow of brewer Richard White. Occasionally she gave him some ale to slake his thirst while digging, but the quantity didn't come up to his expectations and he began demanding more. 1874 William WEBB, George WICK and James WHEELER were charged with doing one shilling's worth of damega to a field of mowing grass, the property of Mr. John BUTLER, of Stratton. Fined 10s each including costs. *The Western Daily Press* 29-05-1874

1875 Alfred TRUEMAN and James TRUEMAN, stealing a hat, the property of Ambrose WILLIS, at Stratton & Hannington. *The Hampshire Advertiser 27-03-1875.*

- James CARTER and Francis YARES, greengrocers of Stratton, were each fined 5s and 7s 6d costs for allowing their horses to stray on the highway. *The Western Daily Press 11-06-1875*.
- Edward GAUNTLETT, farmer and Alfred CLACK, grocer, were charged with killing a cat, of the value of 20s, on the 19th inst., the property of William BURGE. £1 19s 6d costs. *The Western Daily Press 26-06-1875.*
- William BRAIN and John LEES, of Stratton, fined 25s each for keeping dog without a licence. *The Western Daily Press 24-07-1875*.
- -John PAGE, aged labourer, was charged with using a gun without a licence at Stratton on 13th August. Master said he had sent PAGE out with gun to scare birds from his wheat. Bench fined him 50s but to ask revenue to reduce to £1. *The Western Daily Press 10-09-1875*

 - An order was made for the removal of John WHITEHOUSE, an inmate to Langport, Somerset, his home parish. *The Western Daily Press* 27-01-1877.
 - William WILLCOX 17, Edward REEVES 20, William COCKBILL 21, John BUTLER 19, Jesse LAWRENCE 14, Samuel HISCOCKS 18, Henry MAISEY 17, William WILKS 16, Edmond LAY 17, Samuel SHAIL 17, Richard SHAIL 19, and William CHAPMAN 18, labourers, all of Stratton, were charged with wilfully damaging a certain hedge at Stratton, to the amount of 30s, the property of Alfred HUNT, farmer, on the 4th November last. The bench fined MAISEY, LAY and CHAPMAN each 2s 6d and 7s costs. HISCOCKS 5s and 17s 6d costs, and the others 5s and 7s costs each. *The Western Daily Press 27-01-1877*.
 - Thomas HACKLING, a traveller, was committed for two months hard labour for stealing a cloth coat from a conveyance standing in front of the beerhouse at Stratton Crossroads, on Saturday night. *The Western Daily Press* 27-01-1877.

- Frank BARRETT, a schoolboy, of Stratton was charged with damaging a door, the property of Mrt. L. MORSE, grocer, by writing obscene words on it. The bench gave him a severe reprimand, and ordered him to pay 15s, including costs. *The Western Daily Press 09-02-1877*.
- SWINDON POLICE COURT A JUVENILE THEIF David Sewell, aged 12, of Stratton St.

Margaret, was charged with stealing a quantity of jam, half-a-pound of cheese, and a pound-and-a-half of moist sugar, from the house of Jane Adams, spinster, of Stratton St. Margaret, on the 13th April. It seems that during the absence of the prosecutrix and her sister, who lives with her, from her house in the afternoon in question the prisoner entered, took the jams from a pot, some currants and raisins from the cupboard, and the other articles from about the place. The workbox was found to have been opened, but nothing was missioned from this. A little girl, daughter of a neighbour, proved the charge. She saw the defendant enter the house at two o'clock and leave it about an hour after, leaving the front door open. - P.C. Carter gave evidence, and stated that defendant admitted, when he charged him, going into the house, taking the things, and eating them. The defendant was a very bad boy and was in the constant habit of stealing the other schoolboys' dinners. He had got quite out of control of his parents and the schoolmaster, and it was only on the morning of the robbery that the schoolmaster sent for him (the constable) to give him a talking to. - The Chairman said if the defendant transgressed again, he would be sent to the Reformatory School. The mother said he had guite got out of their control. He had been punished in every was to no purpose, and they had never scarcely let him out of doors without some one going to watch him, but notwithstanding this he got into mischief. The Chairman said this being the case they would now send him to prison for ten days and order him to be whipped whilst in gaol.

SECOND COURT (Before Major Calley and Capt. Wykeham Martin). ALLOWING A HORSE TO STRAY. — William GREENAWAY, dealer, of Stratton St. Margaret, was charged by the police with allowing a horse to stray on the highway, in the parish of Stratton St. Margaret, on the 13th inst. Sergt. Strong said on the day in question, in Gipsy Lane, about 11 a.m., he found the defendant's horse, and took it to him. The horse had been about Gorse Hill early in the morning. — The defendant said he put the horse in a field, but someone had thrown down the gate and let it out. — Major Calley said 6d would have purchased a lock and prevented this. — Fined 5s and 9s costs.

A PUBLIC HOUSE ROW. – Joseph SELLWOOD, factory labourer, and William JONES, brickyard labourer, of Stratton St. Margaret, were charged with being quarrelsome and refusing to leave the New Inn beerhouse, Stratton St. Margaret, on the 14th inst. Mr. Tombs appeared for the prosecution, and, after detailing the facts, called Mrs POPE, the landlady, who said on Saturday evening the defendants were in the house quarrelling, and she told them to leave, and she would not allow such conduct. There appeared to be an ill feeling between the defendants, as they had quarrelled in her house a fortnight previous. They would not leave for some time. Some time after they returned, and Jones knocked Sellwood down, which led to a fight. They were both sober. Both defendants admitted this was correct. – Henry RICHENS a labourer, was called by Mr. Tombs to corroborate the complaint, and Mr. Tombs asked the Bench to inflict a severe penalty, as it was very important that publicans should be protected. SELLWOOD, who had been a publican, was well known as a disorderly character, and had been forbidden to enter the house at all, Sellwood said the reason he did not leave when requested was that he was afraid of getting his brains knocked out by Jones, whom he had sued at the County Court six months previously. – The Bench ordered each of the defendants to pay a fine of 11s and 19s costs.

William JONES, the defendant in the last case, was then charged with assaulting Joseph Sellwood, under circumstances reported in the charge of disorderly conduct. Sellwood said the assault was committed without the slightest provocation while he was lighting his pipe at the fireplace. Jones denied this, and said it was SELLWOOD who aggravated him and challenged him to a fight, as he had done scores of times before. – Mrs. Pope was called by Sellwood, but she said Janes was very much aggravated before he struck a blow. – Another witness, John CARTER, on the contrary, swore that the blow was given without the least provocation, and that all language that passed between the two men during the tree hours he was present was quite agreeable and pleasant. – JONES said this man picked up the poker and struck him across the head with it, which CARTER did not deny. – Defendant having called a witnessed, the Bench inflicted a fine of 1s only, and 14s 6d costs, allowing him until Saturday night to pay. *Swindon Advertiser 21-04-1877*.

- Charles LOVEDAY, boilersmith, of Stratton, was charged with being drunk at Highworth on the 22nd inst. Fined 10s and 7s costs. *The Western Daily Press* 15-06-1877.

- STEALING LEAD, William TUNLEY, a master plumber and glazier, and two men employed by him, JONES & BRUSH, charged with stealing 50lb of lead, the property of Messrs. Arkell of Kingsdown Brewery while tepairing roofs. *Bristol Mercury 08-12-1877*.
- William MILLARD, a tramp, was charged with tearing up his own clothes whilst an inmate of the casual ward, on Sunday. Committed for six weeks hard labour. *The Western Daily Press 21-12-1877.*
- 1878 John WILLIAMS, a tramp, was charged with tearing up his clothes whilst and inmate at the Union Workhouse. This offence is becoming a daily occurance. Six weeks hard labour. *Swindon Advertiser 23-02-1878*.
 - John STONE, butcher, of Stratton, fined 10s for allowing his dog to be at large not under proper control. *The Western Daily Press* 19-04-1878.
 - Emma MOORE, a respectably dressed young woman, of Upper Stratton, was brought up in custody charged with stealing a silk umbrella, value 2s, the property of Henry Smith, outfitter, Regent Street, New Swindon. The prisoner had been in Mr. Smith's employ for two months up to Friday last as domestic servant. The Chairman said prisoner appeared to have made a very bad beginning in life, and she was sentenced to one month's hard labour. Swindon Advertiser 18-05-1878.
 - TEARING UP CLOTHES IN THE WORKHOUSE. William JONES, who appeared in the dock clothed in a sack, was charged with tearing up his clothes whilst an inmate of the casual ward of the Highworth and Swindon Union Workhouse, on Monday night. Prisoner said he tore up the things because they were too filthy to wear. The Chairman pointed out that the ratepayers of this union could not afford to find clothes for every lazy fellow who chose to come here and tear up his clothes. Prisoner was strong healthy fellow and could afford to earn his clothes. Mr Superintendent North said prisoner until Monday last was in work at Swindon, as a carpenter, but on that day, he stole a fellow workman's tools, and was booted and pelted out of the town by a crowd. Committed for two months' hard labour. *Swindon Advertiser 18-05-1878*.
 - SWINDON COUNTY COURT Wednesday (Before C. F. D. Caillard, Esq., Judge). Mr. Barnes on behalf of Mr. Radway, of the firm Dore, Smith and Radway, applied to have Alfred HUNT, of Station Road, New Swindon, late of Dockle Farm, Stratton St. Margaret, committed to prison for not complying with an order made on him by this Court under the Bankruptcy Act. His Honour suggested that the application should be allowed to stand over until next court to see if some arrangement could not be come to between the debtor and Mr. Barnes, and after some short discussion this course was agreed to. Mr. Boodle appeared for the debtor.

- CHARGE OF BURGLARY BY A BOY. Walter WESTWOOD, a boy 13 years of age, was brought up in custody on remand charged with stealing 17 ozs. Of tobacco and a quantity of copper money from house of Thomas PAGE, shopkeeper, at Stratton Green, on the 27th last,- Mr. Boodle defended.- On the day in question the prosecutor left his house, and on returning found the shop door leading from the back sitting-room open, an entrance to the house having been effected through a window, which was smashed. The tobacco and money was missing from the shop. On the sitting-room table was found a knife belonging to the prosecutor, which had evidently been used to take the lock off the door, the point being doubled up. The same evening the prisoner was seen coming from the direction of the shop by other boys, to one of whom he went up and said, "Do you want an apple?" One of the boys, Frederick New, held out his hand, when prisoner put into his hand half an ounce of tobacco, and then gave some to the other boys. They asked him

where he got it from, to which he replied that a traveller had given him three ounces which he had picked up on the toad. The same evening a Mrs. BAILEY picked up a packet opposite PAGE's house, which he conveyed to P.C. Carter, who, on opening it, found it to contain 11 ounces of tobacco, three halfpence, and eight farthings. P.C. Carter went to the prisoner in consequence of what the other boys said, and took him to the prosecutors house, where he stated three ounces of tobacco which he had was given him by a boy, wearing a pair of leather leggings, who ran past him. On one of the other boys reminding him what he had told them he commenced crying and said it was a tramp who had given him the tobacco.- Cross-examined by Mr. Boodle the constable denied that the prisoner said a boy was running by and dropped the parcel; that a tramp picked it up and gave it to him (prisoner) three ounces to say nothing about it.- This being the case, Mr. Boodle addressed the Court at considerable length, urging that there was a little of evidence against his client with the exception of the variation in his statement when confronted by P.C. Carter as he was holding a kind of preliminary court of enquiry.- The Bench, after consideration, said there was a certain amount of doubt in the case and this the prisoner would have the benefit of be discharged, the Chairman telling him that what had been stated against him that day would be noted down and remembered if he ever came before the court again.
