(Hereinafter called the Employer)


is insured under the said Group Policy for the amount of Life Insurance Benefit in accordance with the Schedule on the last page hereof.

PRIVILEGE OF CONTINUANCE
In case of the termination of the employment for any reason whatsoever, the Employee shall be entitled to have issued to him by the Legal & General Assurance Society Limited, without evidence of insurability, and upon application made to that Company within thirty-one days after such termination, and upon the payment of the premium applicable to the class of risk to which he belongs and to the form and amount of the Policy at his then attained age (nearest birthday); a Policy of life insurance in any one of the forms customarily issued by such Company, except Term Insurance, in an amount equal to the amount of his protection under the Group Insurance Policy at the time of such termination.
