The well-known and singularly Valuable ESTATES of the deceased, in the following lots;-

- Lot 1.- The compact little *Dairy Farm*, called "The Furze Farm," close to the Swindon Railway Station, comprising a farm house, cowsheds, orchard, yards, garde, and about 36 acres of good pasture Land, is the occupation of Mr. William Greenaway.
- Lot 2.- The substantial built *Dwelling house*, with the farm buildings, yards, and garden, and about 45 acres of first-rate arable and pasture Land, comprising "the Home Farm," situate at Upper Stratton, now in hand. - Lot 4.- Another desirable little *Farm*, called "Bradburn's," also situated at Upper Stratton, consisting of a farm house, cowhouse, barns, sheds, and about 55 acres of first-rate land, of which 35 are arable and remaining pasture, is the occupation of Thomas Greenaway. This lot is subject to an annual payment of £10 5s. to Christ's Hospital, Abingdon.

- Lot 5.- Five valuable Inclosures of Land, also situate at Upper Stratton, containing altogether about 48 acres of which about one half being arale, called "the Seven Halves and Flaxlands," is in hand, and the remainder, being pasture, called "the Great Marsh, Little Marsh, Flaxlands, and Brake," end the occupation of John Tanner. All the above lots are situate in the Parish of Stratton St. Margaret, in the county of Wilts, and are Freehold, with the exception of about 42 acres of lot 5, and the part of lot 12 called "York's Ground," which are Copyhold of the inheritance of the Manor of Corsham.
